D. Wolk moved, seconded by L. Frerichs, to approve Resolution No. 13-111 - Granting Consent to Inclusion of Land within the Territorial Jurisdiction of the City of Davis in the County of Yolo Community Facilities District 2013-1 (Clean Energy). Motion passed unanimously.

Adoption of Fiscal Year 2013-14 Annual Budget Budget Manager Kelly Fletcher: Overview of FY 2013-14 budget. City Manager Steve Pinkerton: Highlights; amendments to budget since introduction.

D. Wolk moved, seconded by R. Swanson, to adopt Urgency Ordinance Approving and Adopting Final Budget of the City of Davis and for the Former Davis Redevelopment Agency for the Fiscal Year 2013-2014, Providing for the Post-Auditing of Paid Demands Certified or Approved as Conforming to Such Approved Budget and Determining the Appropriations Limit of the City of Davis Pursuant to Article XIII-B of the State Constitution. Motion passed unanimously.

Public Hearing: Revisions to Housing Element and Affordable Housing Ordinance Community Development & Sustainability Director Mike Webb: History of affordable housing provisions since General Plan adoption 1987-present—mix of for-sale and rental affordable units; lottery system for purchasers and renters; rental units monitored annually for income qualification; ownership units, initial qualification only. Changing environment—housing market emphasis on infill and sustainable, compact development. Goals of revisions: sustainable affordability for community at large, greater mix of housing types, reduced administration, mechanism to generate funds in lieu of RDA.

Proposed revisions: Focus on rental housing for low and very-low income households. Provide graduated scale for for-sale obligation consistent with planning policies. Allow Accessory Dwelling Units to count toward requirement with limitations/standards. Allow in-lieu fee as option to for-sale (\$50,000-55,000/unit) on a discretionary basis. Retain land dedication option for larger projects.

Proposed Policy Adjustment: Review of the Affordable Housing Ordinance at least every five years. Specific review of the credit for accessory dwelling units to occur no than January 2016.

Mayor Krovoza opened the public hearing.

Jim Kidd: Support. Address needs in the downtown area—stacked flat and vertical mixed use.

Greg Sparks; Jessica Marrell, Sacramento Housing Alliance, and Oly Ottinger, Legal Services Northern CA; Michael Drain and Fernando Silbrien, Mutual Housing CA: Oppose in lieu fees and ADUs. ADUs will not serve low income families or disabled individuals who may need caretaker living with them. Housing needs assessment contains no analysis of what needs will be met by ADUs. Request staff work with community members to address broad range of needs.

Jonathon London and Russell Naches: Davis has 29% of households paying more than 50% of income for housing. Biggest cohort of Davis residents are 22-26 year olds in very low income category. Median home price in Davis is triple national average.

Haddy Thiel: Question exemptions, can exclude lower incomes. Greater diversity leads to greater learning experiences in schools.

Sarah Barnes and Carla Kinney: Support ADU proposal.

Kemble Pope, Chamber of Commerce: Support flexibility, including ADUs and in-lieu fees. Need data driven process; suggest appoint task force that represents all perspectives.

Jason Taormino: Support focus on rental housing instead of for sale units.

Kary Fry: Should look at issue long term. Concern that long term priorities won't be covered by proposed fees.

Mindy Romero: Staff has not provided enough evidence to eliminate concerns expressed by Social Services and Planning Commissions. Need to think about impact of proposed changes on very low income families.

Dave Taormino: Generally support. Oppose 2 items: Projects with 10 units or more, should build within project; if require for fewer than 10 units, should allow in lieu fees. Object to amount of in lieu fees; recommend looking at again, possibly \$30,000. In lieu fee should be developer choice without having to go through hearing process.

George Phillips, Cannery project: Support. Secondary units viable infill component; minimal expenditure of public funds.

Don Fouts, Chiles Ranch project: Support. Currently have 10, hope to expand to

20 ADUs. Would be willing to self regulate ADUs in Chiles Ranch, serve as test period, who is renting, how much.

Mayor Krovoza closed the public hearing.

M. Webb: In lieu fees intended as a proactive measure to keep funding mechanism in place. ADUs should provide housing for working adults, grad students, retired individuals. Other types of units trying to encourage by graduated scale—small units, attached units will fill niche needed by families. Proposal is focusing on providing wider array of housing types. Summarized staff proposed amendments to Ordinance: language needed to clarify proposed ADU requirements consistent with staff report and policy adjustment review.

- L. Frerichs moved, seconded by D. Wolk, as follows:
- 1. Approve Resolution No. 13-112 Amending the General Plan Text Related to Affordable Housing Requirements
- 2. Introduce Ordinance Repealing in its Entirety and Reenacting Article 18.05 of the Davis Municipal Code Relating to Affordable Housing Requirements; amended to include a performance standard for accessory dwelling units (provide common usable interior space to accommodate family living), and technical corrections to menu of housing options
- B. Lee moved, seconded by R. Swanson, substitute motion as follows:
- 1. Approve Resolution No. 13-112 Amending the General Plan Text Related to Affordable Housing Requirements
- 2. Introduce Ordinance Repealing in its Entirety and Reenacting Article 18.05 of the Davis Municipal Code Relating to Affordable Housing Requirements; amended to include a performance standard for accessory dwelling units (shall provide common usable interior space to accommodate family living), and technical corrections to menu of housing options
- 3. Direct staff to provide analysis of providing separate meters for utilities to ADUs. Staff will return with in-lieu fee public hearing and discussion of metering.
- R. Swanson proposed friendly amendment: Council discretion to allow in-lieu fees as an option in any project over 200 units for up to 50% of affordable housing requirement. Accepted by mover. Motion passed by the following vote:

NOES: Frerichs, Wolk

J. Krovoza moved, seconded by B. Lee, to provide the ability to use ADUs to satisfy a portion of affordability 2:1 requirement; shall sunset December 31, 2015. Motion passed by the following vote:

Prop 218 Notices for FY 2013-14 Solid Waste Service Fees – Single Family Residential & Commercial/Multi-Family Residential

Utilities Manager Jacques DeBra: Reviewed Prop 218 notification schedule: July 26 notices mailed, Sept 24 public hearing, December rates effective.

L. Frerichs moved, seconded by D. Wolk to approve the Proposition 218 Notices containing the proposed increases FY13-14 to the rates for the solid waste service fees to be effective beginning December 1, 2013 and future adjustments to such rates for residential, multi-family, and commercial customers. Motion passed unanimously.

Consolidation of the North Davis Meadows Water System General Manager Utilities, Development & Operations Herb Neiderberger: City approached by CA Dept. of Public Health with proposal to consolidate water system for North Davis Meadows County Service Area. Offer included enabling Davis's application for Drinking Water State Revolving Fund financing of the Davis Woodland Water Supply Project to be ranked within a fundable range.

J. Krovoza moved, seconded R. Swanson, to authorize staff to continue negotiations with North Davis Meadows County Service Area with goal of city providing domestic water and meeting objective of qualifying for state revolving loan funds. Tentative agreement will return to Council. Motion passed unanimously.

City Council Liaison Assignments Deputy City Manager Kelly Stachowicz: Reviewed proposed liaison assignments

D. Wolk moved, seconded by R. Swanson to appoint L. Frerichs as voting delegate and B. Lee as alternate for 2013 League of California Cities Annual Conference – September 18-20, Sacramento. Motion passed unanimously.
