Public Hearing: Cannery Request for Community Facilities District (CFD) Formation and Development Agreement Amendment Community Development & Sustainability Director Mike Webb: Total bond amount has been reduced to \$8 million, will fund \$6 million of infrastructure with \$2 million to be set aside until completion of parks and greenbelts. Proposed amendment to Development Agreement pertains to southwest grade separated bicycle and pedestrian crossing, provides options for possible third connection.

Mayor Wolk opened the public hearing.

Mayor Wolk announced that the Public Works Director prepared a report regarding the estimated costs of public facilities and services to be provided for and within the CFD.

- Michelle Millet: Oppose formation of CFD; potential negative impacts include putting at risk future parcel taxes.
- Matt Yancy, Chamber of Commerce: Support establishing CFD at Cannery.
 New Home Company has demonstrated commitment and responsiveness to community.
- Elaine Roberts-Musser: Support formation of CFD. Generally, infrastructure costs are included in cost of new homes or in CFD. Cannery developer has worked to lower CFD amounts. Also, support Development Agreement amendment.
- Ron Glick: Agenda states bond amount is up to \$17 million; discrepancy with staff presentation needs to be addressed if only \$8 million. Amenities that make project marketable for developer shouldn't be paid by future homeowners.
- Ashley Feeney, New Home Company: Thank Council and staff for efforts related to CFD. Support formation.

Bond Counsel Kym Byrens: Initial bond size expected when the CFD proceedings began was for the amount of 17 million; however, reduction of special taxes will result in a smaller bond issue to produce proceeds available for improvements of \$8 million.

City Clerk Zoe Mirabile: No written protests have been received. No persons are registered to vote in the District. Notices of public hearing were mailed on April 20 and published in newspaper on April 28. Owners of taxable property in the District have consented to holding the special elections on May 5. Clerk concurs that special elections may be held on May 5.

Mayor Wolk closed the public hearing.

R. Swanson moved, seconded by L. Frerichs, as follows:

- 1. <u>Approved Resolution No. 15-057</u> Establishing Community Facilities District No. 2015-1 (Cannery) of the City of Davis, County of Yolo, State of California, and Establishing the Boundaries Thereof and Approving a Funding and Acquisition Agreement
- 2. <u>Approved Resolution No. 15-058</u> Determining Necessity for Community Facilities District No. 2015-1 (Cannery) to Incur Bonded Indebtedness in an Aggregate Principal Amount Not to Exceed \$17,000,000 for Providing Public Facilities and Calling a Special Election of the Community Facilities District on the Proposition for Incurring Such Bonded Indebtedness
- 3. <u>Approved Resolution No. 15-059</u> Calling a Special Election and Submitting to the Voters of Community Facilities District No. 2015-1 (Cannery) of the City of Davis Propositions with Respect to the Annual Levy of Special Taxes Within Said CFD and Establishing an Appropriations Limit for Said Community Facilities District

R. Davis moved substitute motion, seconded by B. Lee, to approve up to \$2 million in financing in order to move forward all parks items (staff to use as a reference the table of comparison of timing of CFD eligible improvements with and without CFD approval as guide). Instruct staff to return on May 26 or at a special meeting with updated calculation based on \$2 million target. Motion failed by the following vote:

City Clerk Z. Mirabile opened the 4 ballots received (The New Home Company Northern California LLC, TNHC-HW Cannery LLC, Shea Homes Limited Partnership) and announced that all votes were unanimously in favor.

L. Frerichs moved, seconded by R. Swanson, to approve Resolution No. 15-060 - Declaring the Results of Consolidated Special Elections within Community Facilities District No. 2015-1 (Cannery) on Propositions Regarding (i) Incurring a Bonded Indebtedness in an Amount Not to Exceed \$17,000,000, (ii) the Annual Levy of Special Taxes to Pay Principal and Interest on Bonds, and (iii) Establishing an Appropriations Limit. Motion passed by the following vote:

NOES: Davis ABSTAIN: Lee

L. Frerichs moved, seconded by R. Swanson, to introduce Ordinance Levying Special Taxes to be Collected During Fiscal Year 2015-16 Within Community Facilities District 2015-1 (Cannery), and Declaring Ordinance to Be Effective Upon Adoption. Motion passed by the following vote:

AYES: Frerichs, Swanson, Wolk

NOES: Davis, Lee

R. Davis moved, seconded by L. Frerichs, to introduce Ordinance Approving First Amendment to the Development Agreement for The Cannery Project, Between the City of Davis and THNC Land Company, LLC. Motion passed unanimously.

City Council recessed at 8:26 p.m. and reconvened at 8:39 p.m.

L. Frerichs left the meeting.

Fiscal Year 2014/15 Budget Update – All Funds Revenue and Expenditure Results through March 31, 2015 and General Fund Projection Through June 30, 2015 City Manager Dirk Brazil: Budget is trending in positive direction, nearing 15% general fund reserve goal. Sales tax and property tax revenues continue to increase; staff is cautiously optimistic. For upcoming FY15-16 budget, departments are being realistic and cautious in approach.

Public comments:

• Elaine Roberts-Musser: Commend Council for becoming fiscally sustainable. Important to discuss potential parcel tax in near future.

Council comments:

R. Davis: Is staff reviewing reserve policy? Reserves are usually a certain number of months of operating revenue.

Budget Manager Kelly Fletcher: Over next couple months, staff will be looking at reserve policy and return to Council.

R. Davis: General fund projections need to acknowledge that budget does not represent full accounting of unmet needs: road infrastructure, other city facilities, maintenance backlogs, etc. Need to use opportunity to build into budgeting pro-

cess funding to take care of backlogs; build in way that is sustainable, grow as revenues grow. Encourage staff to look to bolster road infrastructure and possibly create new line item for other maintenance costs.

B. Lee: Request update on roads before next year's budget is finalized. Interested in amount estimated just to maintain current pavement index, and amount to improve pavement index.

R. Swanson: Request bigger picture as move forward with next year's budget. Want to get closer to being fiscally sustainable. Giant backlog of unmet needs; should no longer put projects on hold.

D. Wolk: Revenues are above expectation. As develop next year's budget, build on allocations to long term needs. Need to have discussion about roads, tax measures, additional budget allocations, etc.

Proposed Drought Regulations and Update on Water Use Data Assistant Public Works Director Stan Gryczko: State Water Board currently in session discussing proposed regulations; final decisions have not been made. Staff intends to return to Council on May 26 with update.

Public comments:

- Jacques Franco: Appointed to represent City on Yolo Waste Advisory Committee. Nexus between water conservation and overall waste management and sustainability. Opportunities to save in terms of hard costs and reduction of greenhouse gas emissions.
- Matt Williams: Already have drought surcharge built into water rate structure. Should be transparent regarding production information and how revenues from water system relate to cost of system.
- R. Davis: Request staff provide information on May 26 related to the drought surcharge.
