You previously distributed a survey regarding rezoning sites in Davis which would allow the building of more multifamily affordable housing. I support rezoning ALL of it because the amount of parcels available is woefully small and the need is large. And as you know, rezoning parcels does not insure that the parcels will be used for housing. We need all of them.

In particular, I support rezoning strip malls to mixed use and removing parking minimums.	I also support legalizing the
