1. **Call to Order & Roll Call (6:00)**
6:07 p.m. called to order by Poppenga

2. **Public Comment**

3. **Approval of the August 19, 2020 Minutes**
Arnold moved, second by Poppenga. Motion passed unanimously.

4. **City/District Communications**
Webb: City Council meeting items of interest shared. Overview from UC Davis on campus ready and Healthy Davis Together initiative for safe opening of campus and return of students and teachers. Amplified efforts have been made for students' return to campus. Overview of programs with Q&A. Video streaming available on healthydavistgether.org. Leaf blower regulations discussed. Staff will return with an urgency ordinance to ban leaf blower usage through October. Only if air quality permits.

Poppenga: Questions on leaf blower regulations related to air quality. Asked what type of COVID-19 testing is being used for students.

Webb: Prerequisite to test before students can move in. Student/Staff faculty wide testing also planned for those not living on campus and administering flu shots. Working to incorporate saliva based testing and contact tracing.

Poppenga: With CSU's decision to offer online learning through spring, will UC follow?

Webb: Focus for UCD is fall transition. No decision on re-opening in Spring or talk of it. UC taking it a quarter at a time.

Robust communication effort on social distancing and appropriate behaviors. Incentives like gift cards, student ambassadors being hired to work with student organizations on social distancing efforts.
Bowes: Announced continuation of meal program from the spring/summer through December 31 for anyone 18 and under. One day flu clinic to occur at Harper Jr. High School. Athletics program is offering opportunities to safely condition with voluntary practices. Davis Parent University webinar will occur on October 19 at 5:00 pm. Topic is on advice and strategies to help students deal with pressure. Board meeting summary

on facilities presentation and focus on steps on planned return to campus and efforts and planning for what is required for future/unknown date of return. Hybrid and/or distance learning and return to campus with social distancing discussed.

5. Discussion Items

a. Aquatics Center exploration follow up and briefing

Best: Final report from consultants on joint operation study and highlights reviewed.

Webb: City has received a report from Burke today, not ready to walk through City options today.

Best: Shared quick overview of study and placement options and costs related to each option.

Webb question: Cost estimated include relocating other buildings? Or separately for either options.

Helweg: City has not had a chance to review the current report, but stated that revenue estimates are very conservative due to current rates and will be significantly different when the facility re-opens..

Poppenga: Trustees will also review details of the report.

Webb: Requested an additional City 2x2 for review and continued dialogue of study.

Bowes: Would like to meet again in the next two weeks for further discussion.
