1. Roll Call/Introductions *Meeting called to order at 12:31*

5. County lead

• South Davis Library Planning

The Davis library is at capacity with no room for expansion. A new, second library is the best option and the logical location is south Davis. There is an MOU between the City and the County that specifies that there is 1 acre in Walnut Park that would be for a library.

The next step is to schedule a 2x2x2 with the Davis Joint Unified School District. This should scheduled following new appointments to be made by DJUSD in January.

6. City Lead

• City of Davis current development plans

The City has put together some resources and private development projects are updated on a quarterly basis. Available on the web at http://cityofdavis.org/city-hall/community-development-and-sustainability/test-development-projects. There are links to each project to get details. There was a brief discussion of the sale of Interland but details of this are not yet known.

• Restorative Justice Summit

The City has passed a resolution for a youth diversion program here in the city. It's a collaboration between the police department, school district and the non-profit Yolo Conflict Resolution. It will draw on the experiences of the Neighborhood Court program, but applied towards youth. These are for non-violent crimes. There will be a summit on December 6 (closed to public/invitation only). Robb Davis will be on the advisory board for the center.

• Regional transit

There was a discussion of other cities with aggressive regional transit programs including Boulder, CO and Sacramento. This group would like to find ways to better focus on this as an important issue.

• Partnership to benefit from UCD students/research

There is interest is coordinating with UC Davis students/student services to engage in research to benefit the city and county. The model comes from the University of Oregon, called City Here. A representative from the U of O will be invited to present their model to this group and DJUSD should be included in that meeting.

7. County/City Shared Items

Marijuana

The Board of Supervisors has adopted a moratorium on new applications for cultivation but already has about 100 permits filed.

Last week the Board decided they need to take a closer look at other types of commercial licenses.

The City of Davis has also put a temporary moratorium on commercial activity. Staff is actively working toward development of draft regulation to provide Council with options. The city is hosting a summit on November 28 with the county, other cities, our school superintendent, UC Davis and legal counsel to discuss the actions underway by each jurisdiction.

The City did a traffic analysis and had a meeting with UP to see if they would be receptive to a one-way closure.

PUBLIC Comment from John Swann: Peggy made it clear that there was no certainty that the PUC would back the closure. If there's significant reduction in collision rate with a one-way closure, then the decision would go to the PUC.

Homelessness

The City of Davis has submitted a grant proposal to Sutter Healthcare to support a program based on the Housing First model that is working elsewhere. The funds will pay for housing to provide a bridge until individuals receive their housing voucher. There are willing landlords in Davis with a goal to house 15 people each year. If received, the grant will also support a program called Pathways to Employments based on a model used in Albuquerque.
