#### 6. Discussion Items

### A. COVID Update

Blacklock: Provided an update. The greater Sacramento region did trigger a stayat-home order. Shared some of the restrictions going into place effective midnight, December 11. The county has an extra-cold storage freezer being installed to store vaccines once they arrive. Discussed the priority list for distribution of the vaccine.

Webb: Shared additional information on the restrictions at retail stores. Gave an update on the Healthy Davis Together initiative. The program is looking to expand farther into the county to include skilled nursing facilities. Looking to include a mobile unit to test individuals on-site.

There are ambassadors in the business community that have been trained to help businesses navigate the rules and regulations. Also, there are various apartment units that have been set-up for isolation and quarantine as needed. The state may be making some adjustments to the order as it relates to playgrounds.

Blacklock: It's unlikely that the first batch of vaccines that arrive will cover everyone at the skilled nursing facilities, but hopeful that the second batch will. The state sets the prioritization list of who gets the vaccine first.

B. Status update on termination of property tax exemptions on UCD master leases of residential rental properties in Davis

May: Shared copies of the 2018 LRDP MOU showing that the university would waive their tax exemption for master leases on residential leases in the city. The county contacted the assessor's office to confirm that was happening.

Carson: The city is trying to find out the fiscal impact of the discontinuance of the campus exemptions. Sometimes refunds are issued for these exemptions. City staff has attempted to get this information from the assessor's office, but are unable to get the information because of privacy requirements.

May: Documents held by the assessor's office is confidential, but there may be a way to get the information from the tax collector's office. Will work with city staff to work through this.

## 7. Board of Supervisors/City Council Comments

Provenza: There will be one new supervisor and one new councilmember in the new year. Would like to work together on housing and the homeless issues.

Carson: Would like to add the climate action adaptation plan as a future discussion item.

Arnold: A report came back to council from the joint subcommittee created on the future of policing and a provision of public health and safety in Davis. There were several recommendations made that would require close coordination between the city and the county. Will need to find better ways to help citizens access services from the county. This item is being continued to the next council meeting.

Provenza: Prop 25 didn't pass, which would've implemented no cash bail. Statistics show that 70% of the people in our jail are there because they couldn't post bail.

Public Comment -

Connor Gorman: Supports collaboration between city and county on restructuring public safety. Also agrees with looking into alternatives to cash bail.
