6. Discussion Items

A. Climate Action Initiatives (City/County)

Dianna Jensen (City of Davis) – Provided an overview of what actions were proposed and approved by City Council. This includes the greenhouse gas reduction potential for each of the alternatives and the cost benefit analysis that could help determine which of the actions could become priorities for the city. Looking to release to the public by early August and leave the comment period open until the end of September.

Explained that there is a great deal of information that is on the City of Davis website if anyone wanted more information.

Taro Echiburu (Yolo County) – Talked about the steps that the County has taken on this matter. Shared that a committee has been put together.

Explained that the board has set aside ARP funds for this. Gave an overview of the early action items that can be implemented in the short term. The committee is reviewing a number of proposals that have been submitted by commissioners and members of the public for consideration. A working group was established to work on an RFP that will be put out to bring in a consultant to prepare a Climate Action Plan.

Saylor – Expressed interest in collaborating on things such shared procurement policies.

Echiburu – Explained that an electric vehicle plan policy is being looked into. Considering whether to get the vehicles, or the electric charging stations first.

Webb – Shared that the City is exploring the same options as the County at this time. The fuel facility is coming due for replacement so consideration is being given to closing that facility and instead installing charging stations.

B. Adult Day Health Center (County)

Rinde – Explained that Yolo County contracted with Dignity Health to expand the Adult Day Health Center that would be at the St. John’s site. St. John’s is running into financial difficulties, and there is a construction gap which has caused a pause in the construction. Currently trying to figure out the path forward.

Webb – An American Rescue Plan (ARP) request for this has been submitted and is under consideration by the City Council.

C. Long Range Planning Calendar

Chad Rinde – Gave an overview of the items that were asked to be brought back for March. Items are, an update on North Davis Meadows (connection of the water system to the city) and an update on Animal services.

Partida – Shared that she spoke to Sutter, who said that they had donated to the Family Poverty Reduction Program. Would like an update from the County on that in March if possible.

Rinde – Will see if staff is available to provide an update on this in March or April.

Rinde – There will be an announcement by the health director by the end of the week with new mask mandates that will take effect February 16.
