**5. Discussion Items**

**A. Pacifico Update (City/County)**

*Sullivan: Gave an update on steps taken and where things were with the master lease at Pacifico. A walk-through was done and a list of repairs that need to be made has been compiled. Gave an estimated timeline on how long it should take for the repairs to be made so people can move in.*

*Stachowicz: Explained that mold remediation will need to be done along with other repairs.*

**Public comment**

*Britt Ferguson: Lives in Evergreen Court which is close to Pacifico. Shared that they are opposed to the current set-up at Pacifico and would prefer to have permanent affordable housing at that location.*

**B. Paul's Place Project Update**

*Rinde: Shared that an allocation of funding has been made to match the city's contribution to this project. Davis Community Meals and Housing is required to provide periodic updates on the status of construction.*

*Public comment: Martha Teeter – Expressed support for this project and thanked the City and County for supporting that vision.*

*Provenza: Shared that the Board of Supervisors will be sending a letter to the President and congressional delegation, thanking them for the funds, and let them know what was done with the money. Urged the city to do the same.*

**C. City and County Homeless Update**

*Machado: Provided an update on the winter shelter that is still being used going into spring which was made possible due to additional funding that was received. Shared data on the number of individuals that have benefitted from services being provided.*

*Evans: Gave an overview of items that were covered at the last homelessness commission meeting. Shared what funding is being requested and the variety of services that are being lined up for the coming years.*

*Machado: Shared that there is interest in reinstating the Multidisciplinary Team so that the different jurisdictions can work with the various programs providing services to do better case management where there's overlap.*

**D. American Rescue Plan – County and City Update**

*Rinde: Shared that the County looked at the remaining ARP funds and took action in allocating some of those funds to more programs. Looking into a closeout plan to see where the remaining funds can be used.*

*Will: Gave an update on the mini-grants. The deadline has passed and consideration is currently being given to the applications that have been received.*

*Webb: Provided a general overview of where the city was in the process.*

**E. North Davis water interconnect, staff update**

*Webb: Provided an update on this project that connects this neighborhood that is located in the county, to the city's water system to address some of the water supply issues in that area.*

**F. Youth Initiatives**

*Rinde: Gave some background on this and steps being taken in the development of a youth commission.*

*Saylor: Explained what the goal of the commission is and how it would operate in providing leadership training for youth in the community.*

**G. Long Range Planning Calendar**

*Provenza: It was suggested that an entire 2x2 meeting be scheduled to discuss homelessness. It would be helpful if there were a document that summarizes the efforts and results of what's being done.*

*Saylor: Would like an update on the new city department that the City of Davis is creating.*

*Partida: Would like to discuss climate and green procurement.*

*Webb: Shared that a date is being work on to have the Town Gown in the fall, which is a meeting with the City, County and UC Davis.*
