1. Call to Order & Roll Call

5. Discussion Items

A. Storm Response

Kristin Weivoda gave an update on the events that have taken place since the storms started on December 27. Yolo County proclaimed a state of emergency, and was also added to the federal assistance list at Cal OES. Damage assessments are being submitted.

Gloria Partida wanted to know what steps are in place to help the vulnerable population in the community during situations like this.

Gerardo Pinedo shared that there is a lot of discussion around notification to the vulnerable population during situations like this as this is an area of concern.

Kristin talked about plans to set up a disaster service council. The idea is to have a broad community approach to ensure a wide range of community input is considered to provide a solution that will meet the needs of the community.

Sheila Allen expressed the importance of having lists of vulnerable individuals in the community, to ensure that they are checked on during emergencies to see if they need any assistance.

Stan Gryczko provided a general overview of storm events that took place and action that was taken to deal with those events.

Jenny Tan shared information on messaging that has gone out and how it is handled. The public has been very receptive to it and there is an appetite for information that is sent out in a timely, strategic manner by various means.

Lucas Frerichs expressed appreciation for the crews that have been working around the clock and addressing serious concerns in a timely fashion. Also shared that Yolo Food Bank will be handing out gift cards tomorrow morning. These came from PG&E for grocery stores from around the county.

Gerardo Pinedo commented on how well the city and county are able to collaborate together to resolve issues at all hours of the day.

B. Status update for Hate Free Together Campaign

Jenny Tan provided some background on this campaign, how it came about and its purpose. This is a joint effort between UC Davis, Yolo County and the City of Davis. The framework was presented, and the resolution was passed at the November 30 Town Gown meeting. Shared the work that is being done to move forward on this.

Next steps include asset mapping and research as well as figuring out the budget and funding for campaign. A website is being planned, which would have a similar set-up as the Healthy Davis Together website, which was its own website. There will be community workshops that may be hosted by mediators.
