6. Discussion Items

- COVID-19 Overview – Yolo County

Blacklock: Provided a brief summary for Yolo County. Currently in the red tier which allows some limited indoor activity. Met metrics for orange tier and will be allowed to move into that tier if metrics continue to be met. Focus is now on the upcoming flu vaccination clinics.

Provenza: Health officer can make orders that are stricter, not more lenient than the state.

- Campus Ready – UC Davis

Ratliff: Gave an overview of plans on campus. Looking at dining options at the university – the “to go” only model and what it would look like if dining is able to open. Looking at plans for gyms and fitness. In the area of instruction, looking at the winter quarter and using parameters for red and orange status.

Testing program is progressing. Doing in-campus testing. Also invited students that live in fraternities and sororities to participate in the program, as well as staff that work in student dining and housing. The next step would allow for participation of students living in P3 (Public Private Partnership projects) as well as students, faculty and other essential employees.

Explained how the campus dashboard works. Data on Campus Ready page is everyone participating through the on-campus program, regardless of where they live. Separately, if someone connected to UCD tests somewhere else and comes back positive, they are expected to report those cases for contact tracing.

Blacklock: The county dashboard pulls data from the state database but has no way of knowing if any positive cases are connected to UCD.

Dulcich: Shared that UCD is trying to focus on encouragement and incentive when it comes to student behavior when it comes to doing things other than the gatherings that could result in the spread of the virus. The City of Davis non-emergency line should be called if there is a concern with large gatherings. If the police feels that it's appropriate, they will collect identification data from the individuals, and that will be reported to Student Judicial Affairs.

Ratliff: Has a team of ten contact tracers on campus.

- Healthy Davis Together – City and UC Davis

Ratliff: Yolo County is already doing free weekly testing and UCD is partnering on this. There are efforts to get more gloves and masks. There are incentive programs in the works along with business partnerships, incentivizing people and trying to keep the business local.

Webb: Discussed quarantine and isolation plans as it relates to this program. Personal protective equipment (PPE) is being distributed to the public at the Police Department. There are representatives going to the local businesses checking to see if there's any assistance they may need as it relates to operating safely.

Public Comment -

Eileen Samitz: Still has concerns with off-campus parties. Would like better coordination between campus and city police. Wanted to know why fines are not involved with violations. Asked if the university would pay for housing for students needing to quarantine if campus housing runs out.

Connor Gorman: Likes that the city is handing out masks, but doesn't agree that the Police Department should be doing that. Students are at an age where they need social engagement. There are more students living in Davis because they were not released from their leases. There are a lot of UCD workers looking for protections.

Provenza: Fines are possible if there are blatant violations to health orders.

- **Mental Health Services/Coordination – Yolo County**

Blacklock: The age group of the population at the university is an at risk age group.

Saylor: Mental Services Act requires a 3 year strategic plan. Campus and Yolo County have worked together to integrate mental health services for the student population. There is a NAMI Yolo Chapter on campus (National Alliance on Mental Illness).

- **Housing Updates – City and UC Davis**

Webb: Shared that there are a number of projects that are in the works. Majority are student oriented and some are family workforce oriented. This includes affordable housing. Provided a breakdown of the various developments, status of construction and occupancy numbers.

Ratliff: Provided a status update on the various projects that are in the works both within in the city limits and on campus.

Public Comment -

Connor Gorman: Glad that there is a lot of housing being built, but there needs to be a push for more affordable housing.

Eileen Samitz: Agrees that there needs to be more affordable housing. Asked for an update on timeline for Orchard Park.

Dulcich: No start date of construction at Orchard Park as of yet but looking at completion by 2023.
