

# Civic Arts Commission Minutes Monday, December 4<sup>th</sup>, 2017

#### 2. Approval of Agenda

# A. Approval of Minutes from November 13th, 2017

**Action:** Commissioner Carlson moved and Commissioner Makker seconded approval of the minutes as presented. Motion passed unanimously.

## 5. Regular Items

## A. Maintenance Update

Staff gave a very brief update on current maintenance issues, including: *Imago*-staff is working with the artist to provide more secure footings in Walnut Park.

Anthony Padilla Utility box at 1<sup>st</sup>/E Street was tagged recently. The graffiti abatement crew cleaned what they could, but could not remove all of the paint, so the artist has agreed to come back and do some repair work on the box.

### **B.** 2017 Community Arts Grants

The Commission reviewed application scores and comments for all 21 grant applications received for this grant cycle, and made allocation recommendations for Council approval.

The Poetry Night application was pulled from consideration due to an incomplete application, as it does not contain verification from a fiscal sponsor, as is specified in the guidelines. Staff will follow-up with the applicant to see if there is a way to help support the program in the future.

The Mellon Music Festival was pulled from consideration by Commissioners as they felt there were too many questions they had related to components of the grant that did not make sense within the current guidelines, and actions of the main local point of contact, while not directly affiliated with the applicant, are currently under investigation. Staff will follow-up with the applicant to see if there is a way to help support the program in the future.

This year the program has \$50,000 from general fund budget, and requested funds equal \$86,528. Staff provided a lot of one-on-one assistance with applicants, and commissioners were pleased with the quality and completeness of most of the applications.

In an effort to fund additional qualified projects, the commission recommended that the original allocated amount of \$50,000 be increased to \$71,578, with the overage of \$21,578 coming from Arts and Cultural Affairs funding, also part of the Arts general fund budget. Staff verified that this would be an appropriate use of these funds.

Commissioners discussed whether in the future a protocol should be developed regarding when and how funds should appropriately be spent on programming with UC Davis, and discussed agendizing this to a future meeting.

**Action:** Commissioner Zimmerman made a motion to recommend funding of \$71,578 for 19 applicants at the following levels, with all of the funding coming from FY17/18 Arts budget (\$50,000 from allocated for Community Arts grants, \$21,578 additional funds from Arts and Cultural Affairs Fund). Commissioner Carlson seconded this motion. **Motion passed unanimously.**
