**SUBJECT:** Transition to District Elections – Public Hearing #4 Draft Maps

---

### **Recommendation**

1. Review draft maps and sequencing.
2. Hold public hearing to receive public comment on draft maps and sequencing.
3. Select single final map (effectively choosing either 5 or 7 districts) and sequencing to transition to district elections. Staff will return on November 5 with an ordinance to take effective immediately to implement the change to district elections.

### **Fiscal Impact**

By transitioning voluntarily to districts, the City is not exposed to potentially high costs of litigation. The costs to transition to district-based elections include the costs of the demographer (approximately \$35,000), to be paid out of the existing budget, and staff time to complete the process, which is also included as part of the existing budget. Additionally, the City will be required by law to pay up to \$30,000 in attorney fees to Rexroad Law.

Should the City Council choose to move from a 5-member City Council to a 7-district system, there would be additional costs to add two council members. The direct cost increase is estimated to total approximately \$100,000 per year, although this may vary based on individual council members. Costs include Council salaries, benefits, stipend and travel, equipment and other operational charges specific to the City Council. Indirect costs are unknown at this time but would include staff time spent for and with two additional councilmembers, including potential organizational adjustments to accommodate a larger legislative body. Any such proposals would be made by the City Manager as part of the budgetary process for FY20-21.

### **Council Goal(s)**

The transition to district elections does not pertain to a specific Council Goal, however, it falls under the Goal to secure a safe, healthy, equitable community.

### **Background and Analysis**

The City of Davis is in the process of transitioning to city council voting districts, a process laid out by the California Voting Rights Act (CVRA). This is the fourth in a series of five public hearings on the transition; this public hearing focuses on review of all draft maps and on the proposed sequencing of the voting for each district proposed. At the conclusion of the public

hearing, the City Council will need to choose a final map and sequencing. This map will be brought back to the City Council on November 5 for a vote to approve. No changes may be made to the draft maps; the Council must choose from one of the maps published by October 15. Additional background material about the process and previous public hearings, draft maps, and other district-related information, can be found at [www.cityofdavis.org/districts](http://www.cityofdavis.org/districts).

In order to reach this stage of draft maps, the City, working with demographer Paul Mitchell of Redistricting Partners, has asked the community and City Council for input through a variety of mechanisms. These include public input about Communities of Interest; holding a community workshop to allow participants to learn about the process and draw maps; receiving public testimony at three public hearings held on September 3 and 10 and October 8; incorporating Council discussion; reviewing emails from the public; and providing information about the process at the Davis Farmers Market. Redistricting Partners has taken all of the input, along with 2010 census population data and other information, and has provided a total of ten (10) separate draft maps for consideration: four 5-district maps and six 7-district maps.

Public comments have come in both to the [districts@cityofdavis.org](mailto:districts@cityofdavis.org) email address and through the districts website. Comments have varied greatly, in favor of (or in opposition to) both five-district and seven-district options. Multiple comments have been received requesting that Aggie Village be kept with the downtown area, as well as requests to keep downtown and south Davis separate, not include Mace Ranch with south Davis, leave south Davis and Old East neighborhood intact, not including the Chestnut Park area with downtown, etc.

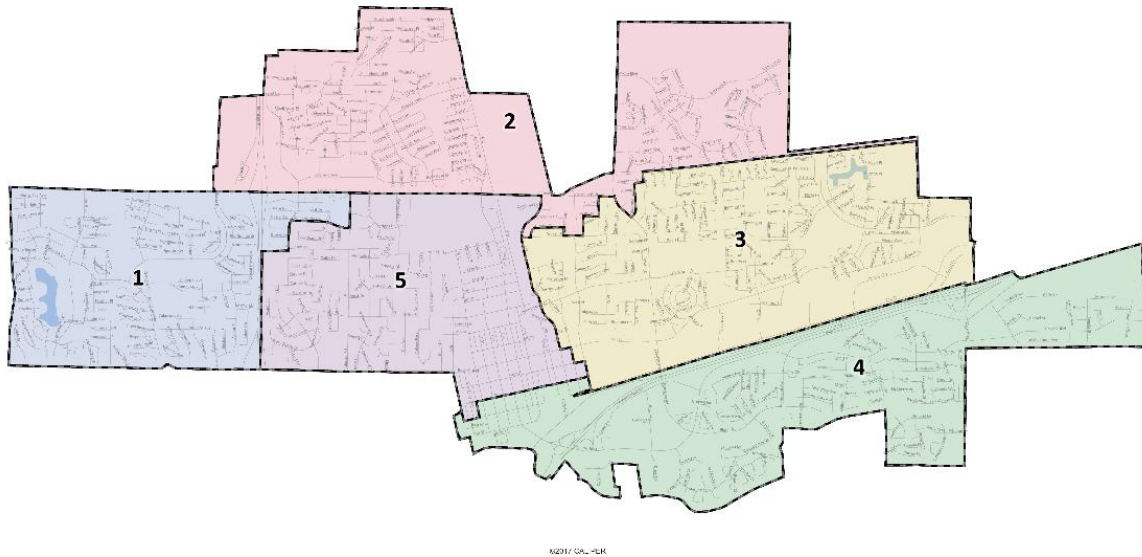
### Map Descriptions

Each map has data included with it to show the 2010 population count within the District, as each District is required to have approximately equal population. The total deviation of population may not be greater than 10%. The data also include the percentages of other demographic groups, such as racial/ethnic minorities, or communities of interest, such as renters. Based on residential housing patterns, no district breakdown in any of the map scenarios was able to provide a voting district with a majority minority racial/ethnic group.

In addition to the maps, staff has included proposed sequencing for each map.

- For the 5-district maps, staff proposes that the districts where the most recently elected councilmembers (Carson, Partida) reside come up for election in 2022, at the same time as the two council seats previously elected at large would otherwise be up for election. The remaining three districts would all come up for election in 2020.
- Sequencing on the 7-district elections is slightly more complicated. Again, the two districts where the most recently elected council members reside would be recommended for the 2022 election, as that coincides with the end of their terms. However, a total of five districts would need to be elected in 2020 in order to become a 7-member City Council. Staff proposes that four of these be for four-year terms and one district be for an initial two-year term, with another election, for a four-year term, in 2022. This results in ongoing Council elections of four districts in one year and three districts at the next election. For each of the seven-district maps, staff has provided two options for which of the districts should have an initial two-year term. Should Council choose a seven-district map, then one of the two sequencing options will also need to be chosen.

## Map 5-1

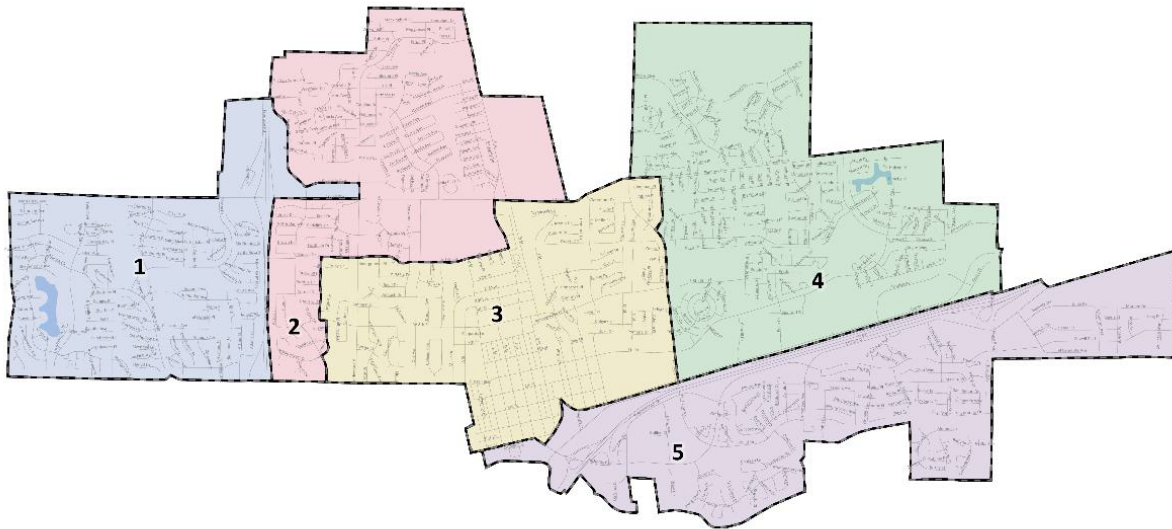


Map 5-1 was taken from a submittal from a member of the public and aims to divide the city into districts based on east, west, north, south and central. The target population for five-district maps is 13,124, so certain areas that residents may consider to be one distinct area, such as south Davis or west Davis, must including additional population, in this case north of I-80 and east of Highway 113, respectively. In addition, one of the requirements for districts is that they are contiguous, which means that the north Davis district must be physically connected, hence the portion of District 2 that is south of Covell Boulevard. This map also places the downtown area and Old East Davis neighborhood in more than one district.

The proposed sequencing for this map is districts 2, 4, and 5 in 2020 and districts 1 and 3 in 2022.

Currently, councilmembers reside in districts 1, 2, 3 and 5. There are no councilmembers in district 4.

## Map 5-2

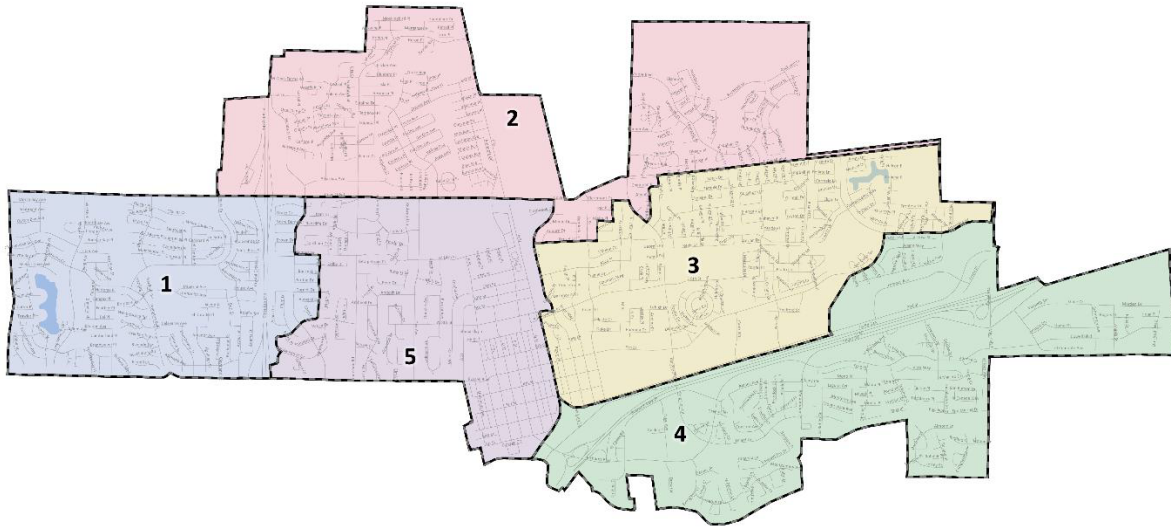
Map 5-2 incorporated public input to achieve try to leave the downtown primarily in one district, include the Mace Ranch area and Wildhorse together, and include all of south Davis in one district and draw districts with attention to renters v homeowners. Four of the five districts have a majority of renters.

The proposed sequencing for this map is districts 2, 3, and 5 in 2020 and districts 1 and 4 in 2022.

Currently, councilmembers reside in districts 1, 2, 3 and 4. There are no councilmembers in district 5.



### Map 5-3



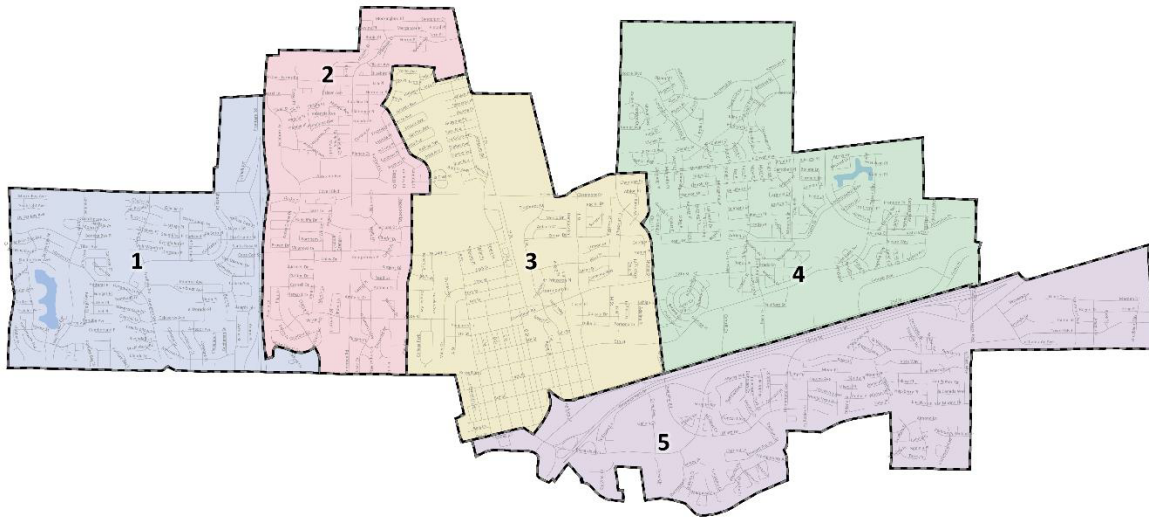

Map 5-3 builds on the concepts of Map 5-1 but pulls population from the Mace Ranch area to add to the “south Davis” district.

The proposed sequencing for this map is districts 2, 4, and 5 in 2020 and districts 1 and 3 in 2022.

Currently, councilmembers reside in districts 1, 2, 3 and 5. There are no councilmembers in district 4.

Map 5-4 (new since 10-8-19)



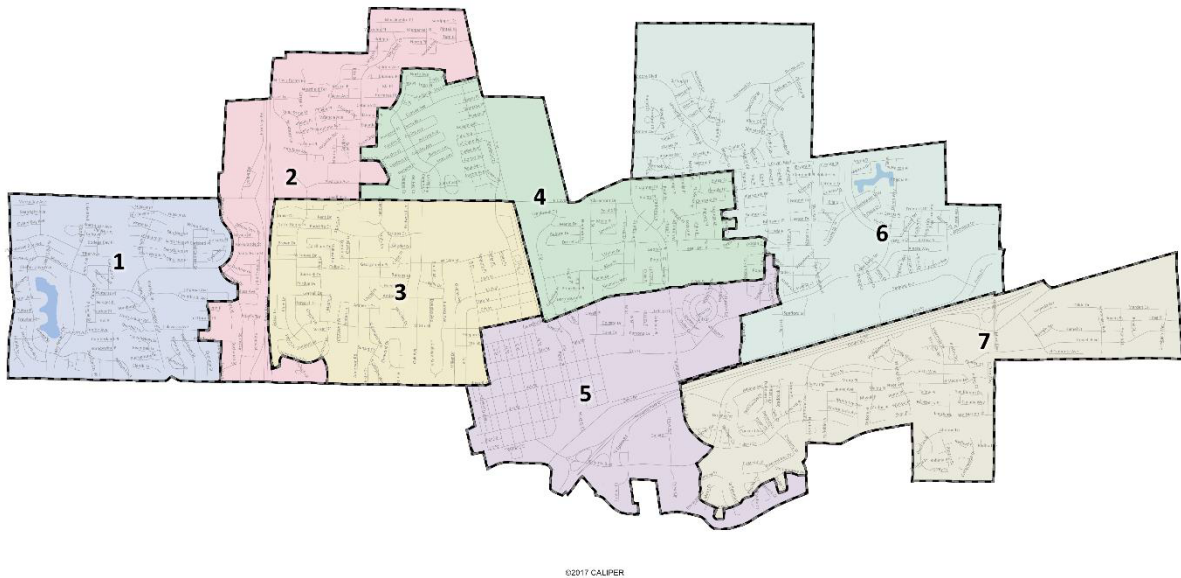

Map 5-4 takes the five-district map and tries to distribute the portions of Davis north I-80 more vertically and more contiguously, while still considering neighborhoods boundaries and other public input. In this option, 4 out of 5 of the districts are majority renter districts.

The proposed sequencing for this map is districts 2, 3, and 5 in 2020 and districts 1 and 4 in 2022.

Currently, councilmembers reside in districts 1, 2, 3 and 4. There are no councilmembers in district 5.

## Map 7-1



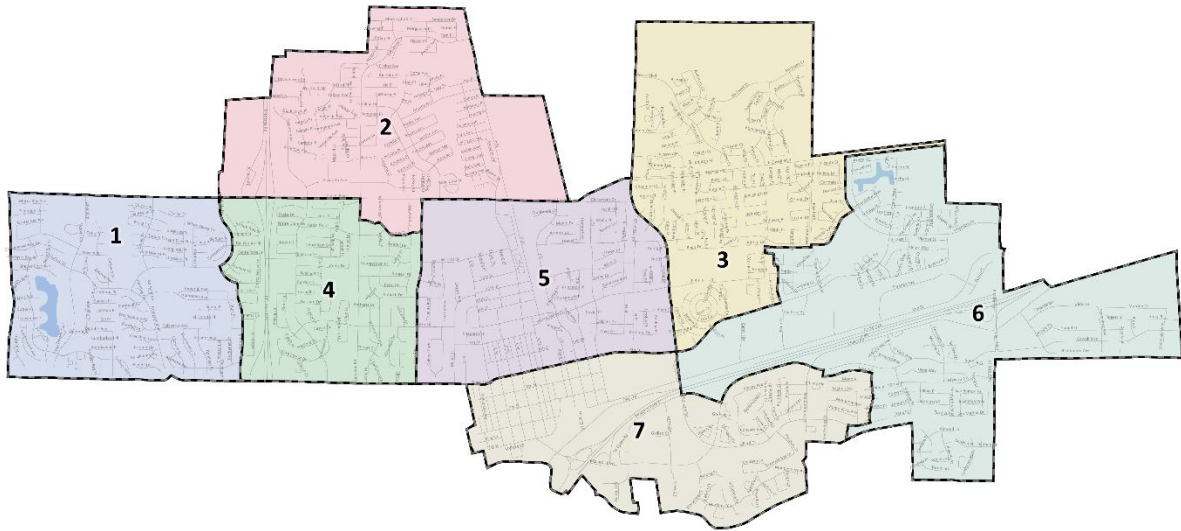
In this map, the demographer worked to follow neighborhood boundaries in a seven-district option.

The two proposals for sequencing for this map are below:

2020 - Districts 2, 3, 5, 6, 7*	2022 - Districts 1, 4, 7
*Initial election for District 7 would be for a 2 year term.

2020 - Districts 2, 3, 5, 6*, 7	2022 - Districts 1, 4, 6
*Initial election for District 6 would be for a 2 year term.	

Current councilmembers live in districts 1, 2, 3, 4, 5. No councilmembers live in districts 6 or 7.

This map comes from a public submittal at one of the workshops, adjusted slightly to meet population requirements. The 7-district maps have a target population of 9375 per district, which necessitates the inclusion of areas like south Davis into multiple districts.

The two proposals for sequencing for this map are below:

2020 - Districts 2, 4, 5, 6\*, 7      2022 - Districts 1, 3, 6

\*Initial election for District 6 would be for a 2 year term.

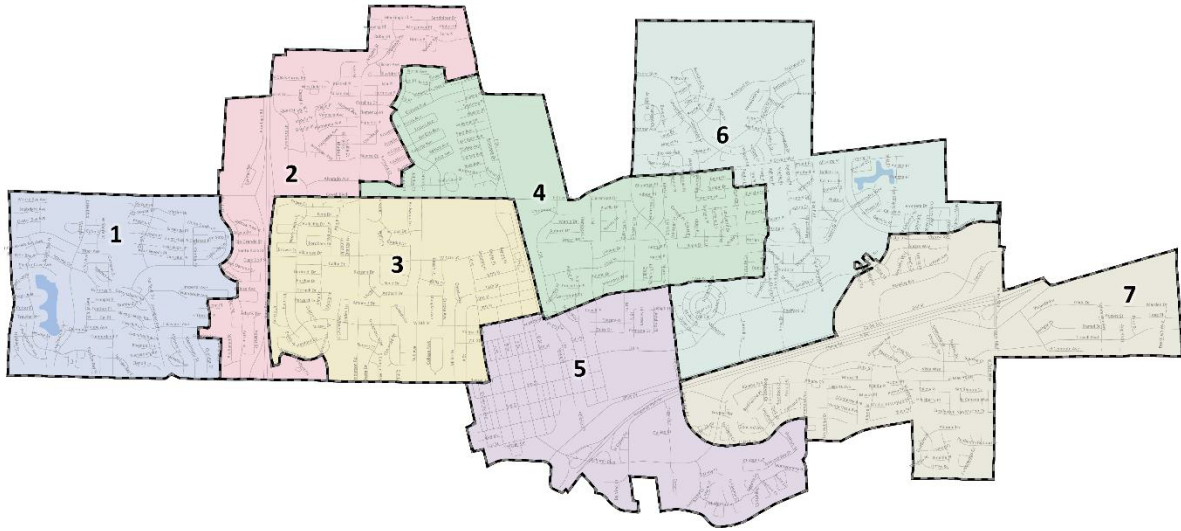

The demographer considered public input and Council discussion on October 8 to create this map.

The two proposals for sequencing for this map are below:

2020 - Districts 2, 3, 5, 6, 7\*      2022 - Districts 1, 4, 7

\*Initial election for District 7 would be for a 2 year term.

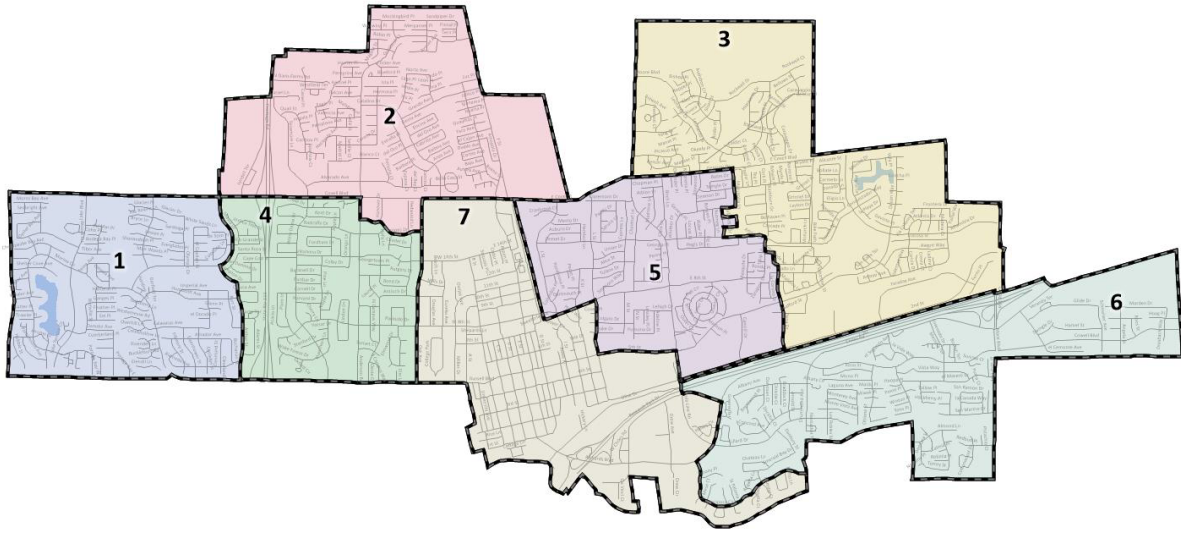

Current councilmembers live in districts 1, 2, 3, 4, and 5. No councilmembers live in districts 6 or 7.

This map is based on map 7-2, but changes the central and eastern districts to ensure one district that is completely within south Davis. Districts 3, 5, 6 and 7 have been “rotated” from their positions in map 7-2 to arrive at this configuration. This ensures that at least one Council seat for someone who lives south of I-80.

The sequencing for this map is proposed below:

2020 - Districts 2, 3\*, 4, 6, 7      2022 - Districts 1, 3, 5

\*Initial election for District 3 would be for a 2 year term.

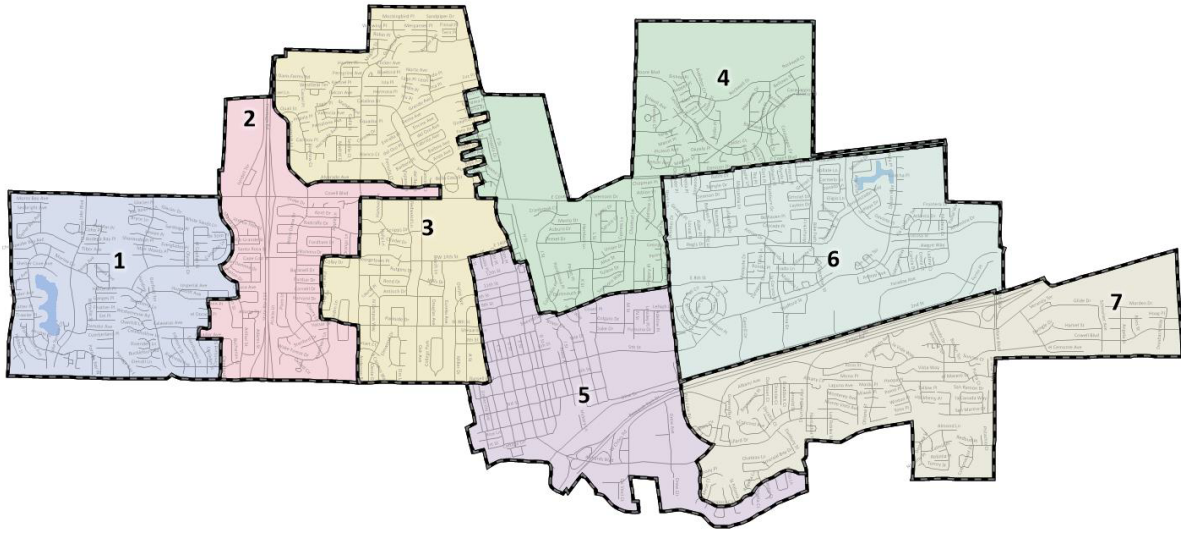
2020 - Districts 2, 3, 4, 6\*, 7      2022 - Districts 1, 5, 6

\*Initial election for District 6 would be for a 2 year term.

Currently, city councilmembers reside in districts 1, 2, 4, 5, and 7. No councilmembers are in districts 3 or 6.

This map is based on a public submittal and adjusted for population. The original intent of the map was to draw districts with a strong majority or super majority of renters. District 2 has 76% renters and District 5 has 83% renters.

The proposed sequencing for this map is below:

2020 - Districts 2, 3, 4, 5, 7\*      2022 - Districts 1, 6, 7

\*Initial election for District 7 would be for a 2 year term.

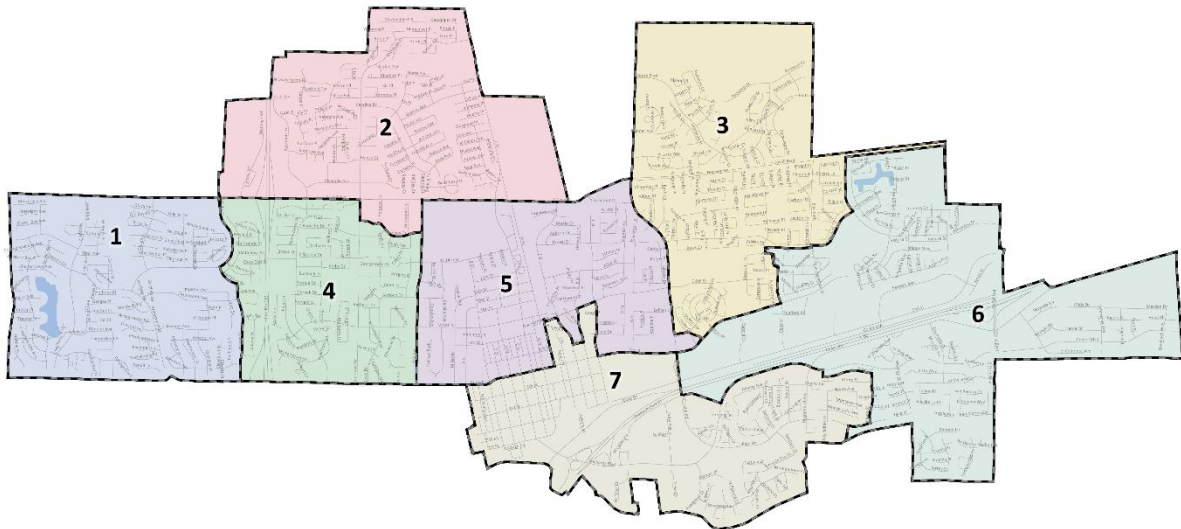
2020 - Districts 2, 3, 4\*, 5, 7      2022 - Districts 1, 4, 6

\*Initial election for District 4 would be for a 2 year term.

Current councilmembers live in districts 1, 3, 5, and 6. No councilmembers live in districts 2, 4 or 7.

The sequencing for the map is below:

2020 - Districts 2, 4, 5, 6\*, 7      2022 - Districts 1, 3, 6

\*Initial election for District 6 would be for a 2 year term.

or

2020 - Districts 2, 4, 5, 6, 7\*      2022 - Districts 1, 3, 7

\*Initial election for District 7 would be for a 2 year term.

Current councilmembers live in districts 1, 2, 3, 4, 5. No councilmembers live in districts 6 or 7.

### **Next Steps**

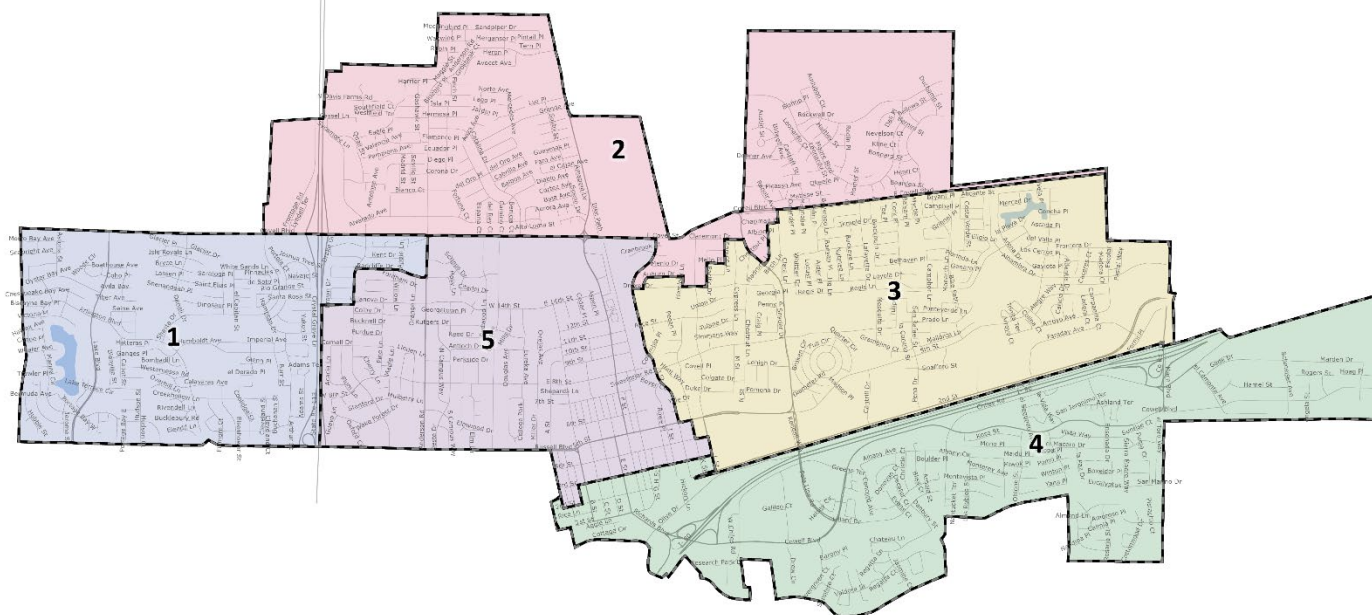
Redistricting Partners will provide additional information at the City Council meeting to detail the considerations used in developing the attached draft maps.

In order to draft the complete ordinance establishing districts for the City Council's consideration and adoption at the November 5 City Council public hearing, the City Council must make several decisions. First, the City Council will need to choose a final map that will then be attached to the ordinance. This will by default clarify the number of districts. Finally, the City Council needs to select the sequencing for the election of members of the City Council. The number of seats and the sequencing of elections will also be included in the language of the ordinance itself. The final map and the sequencing must be published no later than October 29. The final vote to adopt the ordinance and approve the selected map is scheduled for November 5.

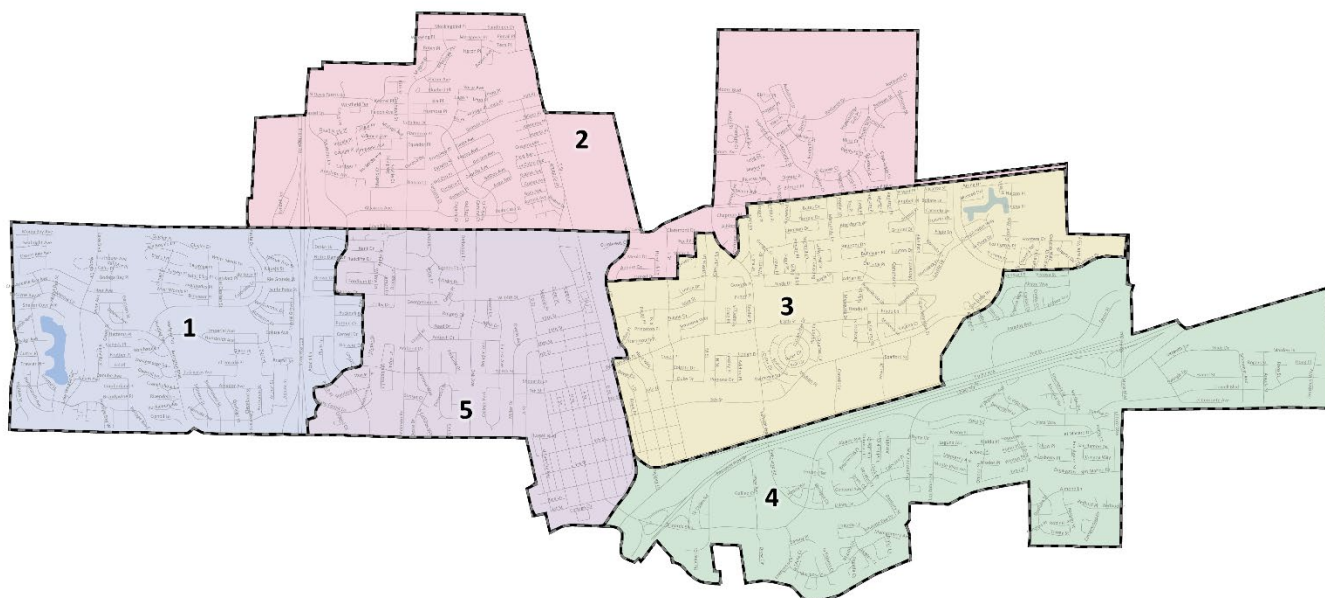

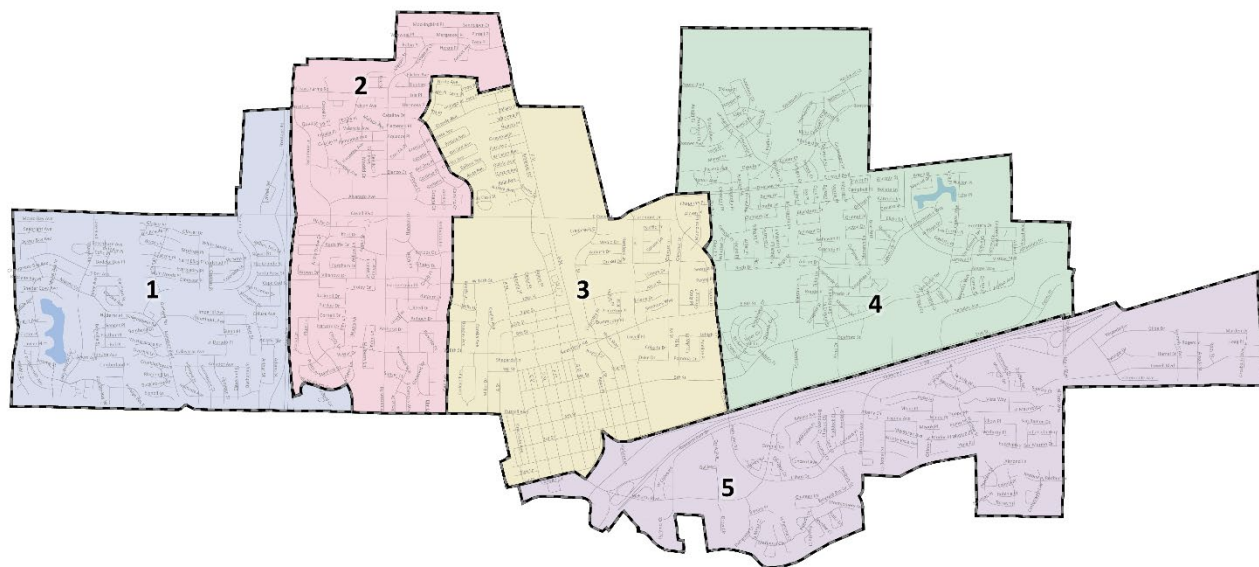

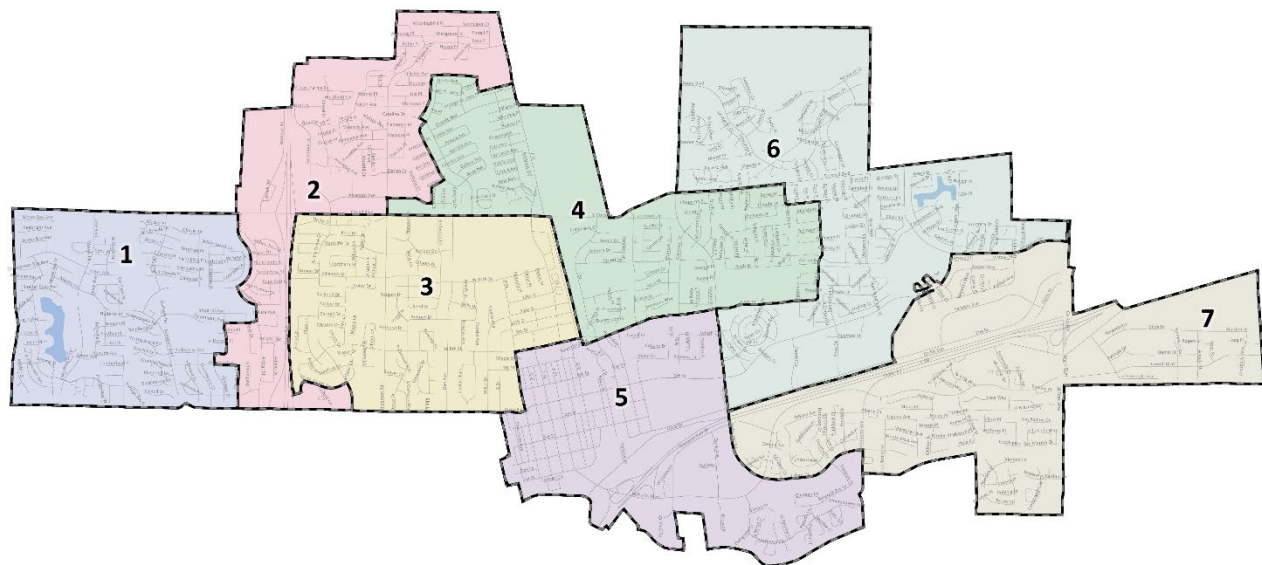
