#### **Background and Analysis**

The Focus Items are intended to provide a degree of short-term attention to ensure progress on roughly seven specific tasks. Once the specific task is achieved, Council may add a new Focus Item or take the next step on a larger task. The Focus Items are not meant to replace the Council Goals but rather provide one mechanism to assist staff with short-term prioritization.

On July 6, the City Council discussed potential Focus Items stemming from the Council Goals. The following seven items were chosen to start:

 Reimagine public safety implementation - Track and regularly report on progress of implementation of the April 6, 2021 City Council actions on public safety.

- Reimagine public safety Crisis Now As a part of the reimagining public safety efforts, bring recommendation to full Council for City participation in Crisis Now.
- Housing Create a council subcommittee and work with city staff and the city attorney to develop funding options, such as an omnibus housing ballot measure, for implementation of housing programs, and return to the full Council for review and direction.
- Housing trust fund Complete and review report with range of options for how housing trust funds can be utilized and for possible sources for building and maintaining the fund.
- **Shelter** Develop options for winter shelter (and ultimately year-round) options and return to full Council with recommendations.
- Sanctioned camping Return to full Council with developed plans for sanctioned camping.
- Mace Blvd Corridor Finalize technical discussions with Yolo County, hold a community meeting and bring recommended plans for action to the Council
- **Downtown aesthetics** Develop plan to address downtown aesthetics, including banners, landscaping, trash removal, sidewalk cleaning, tree health, etc.
