Mayor Krovoza opened the public hearing, and after no comments, closed the public hearing.

- D. Wolk moved, seconded by L. Frerichs, as follows:
- 1. Determine that the proposed Zoning Ordinance text amendment is exempt from environmental review pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines under the general rule that CEQA only applies to projects which have the potential for causing a significant effect on the environment, and that it is categorically exempt from the provisions of CEQA Guidelines Section 15305 under Class 5, Minor Alterations to Land Use Limitations
- Introduce Ordinance Amending Chapter 40 of the Davis Municipal Code Pertaining to Definitions, Permitted and Conditional Uses in the Districts of C-C, M-U, C-I, R2-CD, R-C, R-HD, R-R, R-T, R-1, R-2, R-3, R-2-MH, R-R, I, and All Planned Development Zones of a Similar Nature, which is consistent with State law and the City's 2006-2013 Housing Element of the General Plan Implementation Program

Motion passed unanimously.

ment for DJUSDDeputy City Manager Kelly Stachowicz: Proposed fence will block off area for
softball use and preclude any other use. Minor changes to agreement are still
being finalized by DJUSD. Recreation and Park Commission unanimously sup-
ported proposal.

Public comments:

- Becky Rigoo: Request Council move forward with improvements. Support girls and young women dedicated to softball.
- Dennis Foster, Athletic Department Davis High School: Several planning sessions conducted at field, provided \$50,000 to start improvements this summer.
- Sam Swimley and Mindy Dufraine: Softball Coaches. Girls deserve field built for dedicated use. Only varsity sport that hasn't had any upgrades in facility.
- Catherine Slaybaugh, Marissa, Sadie Mariko, and Patty Sloney: Students, softball players. Installing temporary fence every day is a hassle; would like to field to be proud of.

K. Stachowicz: Booster clubs working with Tree Davis to fundraise for trees to plant. Staff does not consider along the outside of the outfield an appropriate location for tree planting, should be placed north of third baseline; will need to consult with city staff before proceeding.

- R. Swanson moved, seconded by D. Wolk, as follows:
- 1. Approve Resolution No. 13-074 Authorizing the City Manager to Execute a License Agreement with the Davis Joint Unified School District for Improvements on the Softball Field Located Partially on City Property in

Community Park (Davis High School Varsity Girls' Softball Field), including the following:

- a. Construction of a permanent 6' chain link fence to surround the field and which will be located partially on City property.
- b. Pouring of a concrete pad to replace the decomposed granite surfacing at the existing batting cage site.
- c. Demolition of existing 6' high chain link dugout and replace with an 8' fully enclosed chain link dugout, with a wood covering on a concrete pad. The dugouts will also be relocated further down the line to allow for bleachers (bleachers will be located on District property).
- d. Fencing in the bullpen (along the third base line completely on all sides).
- e. Allowing trees to be planted along the third baseline and north/north-east of facility.

2. Direct staff to come back within 12 months with status update. Motion passed unanimously.

City Council recessed at 8:05 p.m. and reconvened at 8:10 p.m.

Options for First State Bank of NW Arkansas Property - Mace Curve 391

City Manager Steve Pinkerton: Need balance quality of life and sustainable goals with enough economic development to generate revenue for community. Staff recommendation is to explore options to leverage the Mace Curve 391 and decline to proceed with the USDA Natural Resources Conservation Service grant.

Property Management Coordinator Anne Brunette: Overview of Measure O, approved in 2000; funds acquisition, operation and maintenance of open space and related public facilities. Currently collect \$600,000 per year.

Public comments:

- Mark Hoshovsky, Roberta Millstein, and Greg House, all from Open Space & Habitat Commission; Gene Jackman; John Johnston; Henry Hauss; Lynn Nittler; Karen Andrews; Bob Schneider; Alan Pryor, Sierra Club Yolano Group; Lee Bartholomew; Jay Feldman; Jennifer House; Stephen Souza; Rodney Robinson; and Ken Wagstaff: Oppose staff recommendation to decline acceptance of the NRCS grant. Comments included: Opportunity to preserve open space for future, great project, rare \$1+ million grant. Community priority proven by passage of Measure O. Object to process; should not plan fringe development in secretive manner; little public input. Decision may have CEQA implications. Best open space purchase in city's history, opportunity will not repeat with escalating prices. Consider other parcels for business park development.
- Matt Williams: There may be better opportunities, more study needed.
- Michelle Clark, Yolo Land Trust: 20 year partnership with Davis; 17 projects. City owns fee title to Mace Curve property; Yolo Land Trust is sole recipient of grant.
- David Morriss, CEO-Capitol Corridor Ventures: Davis must attract and retain companies; Mace and I-80 is the ideal site for business park. If ease-

ment progresses, will push development to Solano County. Secured contract on Shriner's property and offered to city; issue is whether city would rather have conservation on land swap.

L. Frerichs moved, seconded by B. Lee, to proceed with acceptance of USDA Natural Resources Conservation Service (NRCS) grant funding and approve Resolution No. 13-075 - Approving the Resale of the Mace Curve Property and Authorizing the City Manager to Complete the Resale for the Purposes of Permanently Protecting the Agricultural Values and Open Space Character of the Property.

R. Swanson moved substitute motion as follows:

- 1. Determine that exploring options to leverage the Mace Curve 391 (also known as the First Bank of NW Arkansas Property) to meet several of the City Council's stated policy goals outweighs the current value of a USDA Natural Resources Conservation Service grant.
- 2. Authorize staff to notify the Yolo Land Trust (YLT) that the City will decline to proceed with USDA Natural Resource Conservation Service (NRCS) grant funding as an offset from the original purchase of the Mace Curve 391 property.

No second.
