plication #14-57: General Plan Amendment #08-14, Rezoning/Preliminary Planned Development #06-14, Annexation #2-14 Tim Ruff, Nishi Gateway Management Partner: Commit to LEED ND certification process, ongoing process throughout development. If not able to reach LEED, will focus on sustainability plan to make sure meet LEED equivalents. Not requesting CFD to finance public improvements, confident that entitlements will fund improvements.

Mayor Wolk opened the public hearing.

- Michael Bisch, Davis Downtown; Emily Ziser, Chamber of Commerce; Neil Ruud; Kemble Pope; Alan Pryor; Emily Messa; and Mario spoke in support of the project. Comments included: 45 acres on campus border, next to downtown and Arboretum, transit oriented infill. Strong ratio of housing to business. Improve Richards Olive Corridor. Provide space for research. Generate tax revenue, broaden tax base, expand employment opportunities. Provide options for students and young professionals. Good fit for Davis. Cooperative effort between city, university, county, land owner.
- Alan Hirsch: Nishi Working Group has been meeting for over 12 months.
 Details still to be worked out, financial, transportation, environmental. Cautiously optimistic that issues can be resolved.
- Jim Zanetto, project architect: Support LEED neighborhood design certification process. Neighborhood design has 2 steps, planning stage and built project stage to monitor what is actually constructed.
- Dan Carson: Reviewed economic analysis, strong positive economic impact. Direct fiscal impact to city could be as much as net \$2 million.
- Jeff Miller: Finance and Budget Commission reviewed project; recommend Council not move forward until all questions answered. Address 20 year build out, understand from fiscal standpoint. Discuss fund after project is developed.
- Stephen Souza: Submitted letter on behalf of 9 former elected. Project is strong and worthy to bring before voters, should place on June 2016 ballot. Years of collaboration.
- Eileen Samitz: Concerns about Nishi project. No development agreement yet. Should address FBC concerns. 2 major infrastructure costs not included in analysis, parking structure and Putah Creek Parkway Bridge. Sales tax and property tax overstated. UCD has to approve and access actually be built. Student housing should be on campus.
- Chris Granger, Cool Davis: Need to make sure to get most of sustainability plan into structure of accountability. Missing method to value mitigation of greenhouses gases. What is list of greenhouse gas emission items? What does fund look like? How value? Use cap and trade fund? Use corporate?
- Ken Wagstaff: Key to getting public to accept project will be connection to university. Community will come out against project if voters cannot be sure that access for motorized vehicles is built. Show not have any more pressure on Richards tunnel.
- Matt Williams: Developer commitment to no occupancy until tight diamond and Richards Blvd. improvement completed. Occupancy won't occur until 2022.

- Nancy Price: Fiscal analysis is crucial, in form that public can understand.
- Steve Wheeler: City needs to better coordinate sustainability with community development. Development Agreement and baseline project features not sufficient. Parking needs to be strengthened. Need broad verifiable package of sustainability.
- Louise: Should take more time to process. Put on ballot later.

Mayor Wolk closed the public hearing.

Phasing

B. Lee: No access to Olive Drive unless Richard Blvd interchange improvements occur. Emergency vehicle only.

R. Davis/L. Frerichs: Allow public transportation. B. Lee concur.

Community Development Administrator Katherine Hess clarify: Nothing on site until UCD connection is built. No access to Olive Drive other than emergency vehicles and public transportation until completion of Richards interchange and bridge over Putah Creek. Bridge happens to allow emergency vehicles and buses. No private vehicles until Richards.

In lieu fee/contribution to affordable housing trust fund. Bring back more information on unit sizes and affordability by design elements.

FBC Chair & Vice Chair confer with staff and economic consultants

Parking

Hard cap on vehicle trips.

R. Davis: Request one more discussion on reducing parking. As low as reasonably possible. Concur.

LEED Certification

LEED ND, possibly platinum level, in baseline features

Tim Ruff: Agree to LEED ND in baseline
