Proposal to Change the Name of Sutter Place to Risling Court City Manager James Antonen outlined staff recommendations.

Melvin Trujillo and Jack Forbes spoke in support of the proposed resolution to change the name of Sutter Place to Risling Court and relayed background information regarding Risling's activities as an education advocate.

Cecilia Escamilia-Greenwald, Human Relations Commission, and Cassandra Hencher also spoke in support of the proposed resolution.

S. Greenwald moved, seconded by S. Souza, approval of Resolution No. 06-06 – Changing the Name of Sutter Place to Risling Court. The motion passed by the following vote:

Mayor Asmundson presented the resolution to Barbara Risling.

Resolution Regarding Withdrawal of Troops from Iraq Councilmember Stephen Souza explained that community members contributed to the language of the proposed resolution in conjunction with Davis Peace Coalition and Capitol Region Chapter of Military Families Speak Out. He stated there was no city staff time expended.

Twenty-four individuals and representatives from Military Families Speak Out, Davis Peace Coalition, ASUCD Senate, and the Human Relations Commission spoke in support of the proposed resolution. In addition, two neighborhood petitions were submitted. Reasons cited include: opposition to war and treatment of soldiers, loss of loved ones, and importance for the city to indicate its opposition on record.

Twelve individuals spoke in opposition to the proposed resolution. Reasons stated include: city council should focus on local issues as national ones are outside of their jurisdiction, proposed resolution does not reflect opinion of the majority of the community, proposed resolution is divisive and may send a negative message to troops.

Councilmember Souza read the proposed resolution in entirety for the record.

S. Souza moved, seconded by S. Greenwald, approval of Resolution No. 06-08 – Calling on President Bush to Bring Our Troops Home. The motion passed by the fol-

lowing vote:

Ordinances Modifying Municipal Code and Establishing No Parking from 6 a.m. to 10 a.m. within the Old North Davis Neighborhood to Accommodate Street Sweeping

City Manager Antonen explained that the Old North Davis Neighborhood Association requested deferment of discussion of the proposed ordinances for one month. Council concurred.

Consideration of Options for June Ballot Measure Renewing the Parks Maintenance Tax Finance Director Paul Navazio provided information regarding options to consider in developing a parks tax measure and outlined a timetable for submission of the measure to coincide with the June 2006 election.

- T. Puntillo moved, seconded by S. Souza, direction to staff as follows:
- 1. Prepare the text of the Parks Tax Renewal Measure to appear on the June 2006 ballot.
- 2. Prepare resolutions calling for the June 2006 election and requesting Yolo County Board of Supervisors consolidate the election with the existing scheduled election.

The motion passed by the following vote:

R. Asmundson moved, seconded by S. Souza, approval of formation of a Council Subcommittee consisting of Councilmembers Puntillo and Souza to work with staff regarding the parks tax measure. The motion passed by the following vote:

Proposed Dispensation of City Property Adjacent to Haussler Home at 2627 East Covell Boulevard Community Partnership Coordinator Anne Brunette explained the property in question was originally intended to provide a buffer for the Haussler home from the new Wildhorse development and is no longer a necessity as the lot currently has a pending subdivision application.

- D. Saylor moved, seconded by T. Puntillo, direction to staff as follows:
- 1. Prepare an appraisal of the land east of the Haussler home on Covell Boulevard, considering options for both undivided and subdivided land, and return to Council for further direction on whether to treat the property as surplus.
- Refer the property dispensation proposal to the Recreation and Park Commission.

S. Greenwald moved substitute motion to direct staff to return to Council with an estimate of the cost for continued maintenance of the land before any funds are spent on the appraisal. No second.
