- T. Puntillo advised that the Transportation Authority has authorized the purchase of 13 big buses, 2 minivans and 2 cut away vehicles that are clean air vehicles.
- S. Greenwald reported on the Budget & Finance Commission meeting where they discussed their concerns with the Target EIR. She also advised that the Senior Commission met and Care is short on volunteers.
- S. Souza and T. Puntillo, the Council subcommittee on the Davis Indoor Sports Center, met to discuss the possibility of saving the facility and there are potential solutions.
- R. Asmundson attended the air quality meeting. SACOG is doing workshops in the area, including Davis.

Public Comment

Don L. Meyer, Chief Probation Officer was present to introduce himself and notify the city that probation is available and present in Davis. They are working on a truancy program with the School District in an effort to reduce truancy that focuses on prevention. Case loads for officers are approximately 40 juvenile cases per officer and 1,200 adult cases.

Mr. Lee stated that he was raised in and around law enforcement personnel. He is concerned that there is not enough attention being given to the racial profiling. He would like to have the item agendized for a future Council meeting to allow citizens to come forward and inform the Council of activities that are taking place in Davis. He would be willing to meet either formally or informally. He was advised to contact the Council via e-mail.

S. Souza, speaking as a private citizen, advised that the Yes on G campaign is up and running.
