Inclusive Home Design – City Visitability/Accessibility Policy

Housing Programs Manager Danielle Foster presented an overview of the proposed visitability/accessibility policy.

Public input on proposed policy:

- Support for accessibility, not visitability
- Davis should be the vanguard in development of an accessibility policy and provide for future needs of the community
- Professionals should be hired to provide recommendations to Council
- Infill development does not allow for full inclusion as smaller footprints of dwellings hinder accessibility
- New housing should be 100% accessible with exceptions allowable
- Proposed model state ordinance does not accomplish much
- S. Souza moved, seconded by D. Saylor, approval of Resolution No. 06-172 Adopting a Policy of a Citywide Target that One Hundred-Percent of All New Housing Units Built Within Projects that Require Legislative Approval By the City Council Be Visitable, as amended by an increase over staff proposed fifty percent visitability.
