Proclamation in appreciation of Pacific Gas and Electric Company for its contribution to the City of Davis 2006-2007 Street Smarts Campaign Ceremonial

Item submitted by Councilmember Should the City enter into negotiations with representatives of Mace Covell Gateway, LLC to acquire the property known as Shriners (parcel # 071-130-01) a 228 acre site for the possible purposes of developing a regional park, emphasizing active play fields for youth sports, organic farms and a passive habitat buffer? S. Souza advised that this came to him via discussions with a neighbor regarding a sports park. He also had discussions with the property owners of the Shriners property to see if they were willing to sell. He would like the Council to determine if staff should look into the acquisition of this property for the purpose of a sports park.

G. Phillips representing Steve Guidaro (Shriner property owner) was present to answer questions.

R. Asmundson moved for adjournment and with no second the motion died.

Main Motin by D. Saylor, seconded by S. Souza to direct staff to investigate the potential acquisition of the Shriners property and at the same time examine other locations adjacent to the city.

M. Dashka spoke in favor of a sports park in any location, but the city needs to move forward.

D. Greenwald asked what the rules would be if there would be a future Measure J vote should residential conversion. S. Souza advised that it would require a Measure J vote.

J. Belenis spoke in favor of a sports park in Davis and that the Council move quickly. He also suggested that the city staff look at what Carson City and Redding have done with sports parks.

Substitute motion by S. Greenwald, seconded by R. Asmundson to amend D. Saylor's motion to include as an equal weight for a sports park, discussions with the Signature property owners.

Substitute, substitute motion by D. Saylor, seconded by R. Asmundson to direct staff to enter into preliminary negotiations for acquisitions for the Shriners property as open space and to look into alternative sites for a sports park. The motion passed by the following votes:
