The City Council of the City of Davis met in regular session beginning at 5:30 p.m. in the Community Chambers, 23 Russell Boulevard, Davis, California. The meeting was called to order by Mayor Greenwald.

Closed Session

Items pulled from the Consent Calendar Resolution 07-184 authorizing the City Manager to execute an interim change in use of 512 Fifth Street property by Davis Community Meals (DCM) as a cold weather shelter during the 2007-2008 cold weather season, with automatic renewals for one year cold weather season

Approved

Directed Davis Community Meals (DCM) to work with the Davis Police Department and Davis Community Church to continue enforcement of a no loitering policy in the area surrounding the house at 512 Fifth Street and the east side of the church closest to the shelter, and to coordinate a referral system for the shelter each year to include an annual renewal of a Memorandum of Understanding between DCM and Davis Community Church

<u>Directed staff and DCM to notice the surrounding neighborhood in advance of the shelter opening each year to include details of the shelter and emergency contact information for Davis Community Meals, and to hold neighborhood meetings as staff deems necessary</u>

D. Saylor moved, second by S. Greenwald to approve the above. Motion passed unanimously.

Public Hearing: Ordinance Repealing and Re-enacting Chapter 8, Article 8.01, of the Davis Municipal Code Public hearing was opened and with no comments was closed.

S. Souza moved, second by D. Saylor introduction of the ordinance repealing and reenacting Chapter 8, Article 8.01, of the Davis Municipal Code and adopting by reference the California Code of Regulations Title 24, 2007 Edition of the California Building Standards Code including the Administrative Code, Building Code, Electrical Code, Mechanical Code, Plumbing Code, Energy Code, Historical Code, Existing Building Code and Referenced Standards Code including Appendix Chapters, and Amending Those California Building Standards as Identified Herein, Through Express Findings of Local Necessity. The motion passed unanimously.

Public Hearing: Amendments to the Davis Municipal Code regarding Fire Codes Amendment to the Davis Municipal Code to Adopt the 2007 Fire Code and to Remove the Fireworks Prohibition from Chapter 26 and Add to Chapter 13 and Ordinance Repealing Article 26.01.050, 26.01.060 and 26.01.070 of the Municipal Code and Adding Chapter 13 Article 13.002 Regarding Fireworks

Public hearing was opened and with no comments was closed.

D. Saylor moved, second by S. Souza to introduce the ordinances moving the fireworks prohibition from Chapter 26 to Chapter 13 and to adopt Part 9 – the California Fire Code and for the City Attorney to make the necessary technical changes to the ordinance. The motion passed unanimously.

Public Hearing: Mace Ranch Industrial General Plan Amendment and Rezone The public hearing was opened.

Mr. Nishikawa, the applicant, thanked staff for their due diligence on the project and spoke to the application.

A resident spoke in favor of the project. The rezone would allow more flexible utilization of the property.

With no further comments, the public hearing was closed.

D. Saylor moved, second by S. Souza to take the following action:

Intersection Review of Pole Line Road Overcrossing at Oakshade Town Shopping Center D. Saylor moved, second by S. Souza to shave the median island, lengthen the pocket of the merge lane and to post a sign for vehicles coming over the overcrossing. The motion passed unanimously.

Fiscal Year 2007/2008 First Quarter Budget Update A summary of the first quarter budget was provided.
