S. Souza moved, seconded by D. Saylor, approval of the consent calendar as listed above. Motion passed unanimously.

Public Hearing: Haussler Subdivision Proposal to Reconfigure Greenbelt and Residential Property at 2627 E. Covell Boulevard General Plan Amendment, Zoning Amendment, Final Planned Development, Tentative Map and Negative Declaration

Principal Planner Michael Webb summarized the project, which involves a land swap between the City and applicant to realign the existing greenbelt and residential property. The reconfigured property will result in a 4 unit subdivision after the existing residence on the property is demolished.

Mayor Asmundson opened the public hearing.

Mark Rutheiser, applicant, stated the site is constrained by drainage issues, and the affordable housing requirements and city fees are cost prohibitive for the project.

Dennis Smith stated the design should blend visually and aesthetically with the neighborhood, and the bike path should be more secure with improved pathway surface and lighting.

Ed Patrick asked if there is any ability to modify setbacks in the future if they are approved by Council tonight, as he is concerned over which trees will be removed.

Mayor Asmundson closed the public hearing.

- 1. Adopt the Initial Study/Negative Declaration prepared for the project pursuant to Section 15070 (a) of the CEQA guidelines
- 2. Introduce Ordinance Amending Chapter 40 of the Davis Municipal Code Amending Planned Development #3-89, Area H Low Density Residential Haussler Property Consisting of Approximately 0.8 Acres Located on the North Side of Covell Boulevard, South of Moore Boulevard, East of Whistler Court and West of Sargent Court
- 3. Approve Resolution No. 09-011 Passing an Intent to Adopt an Amendment to the General Plan Map for Changes in the Boundaries to the Community Greenbelt and Residential Low Density Areas for the Properties Located at 2627 E. Covell Boulevard (APNs 071-140-06 and 071-262-23)
- 4. Approve Planning Application #27-05, Revised Final Planned Development #04-05 and Tentative Map #05-05 based upon the findings and subject to the conditions contained in the staff report

City Council recessed at 8:27 p.m. and reconvened at 8:34 p.m.

Update on Fifth Street Corridor – Civic Engagement Efforts and Revised Workplan Principal Planner Michael Webb provided an overview of community outreach efforts for the Fifth Street Corridor and presented the proposed workplan. City Engineer Bob Clarke outlined data needs and specific issues regarding side streets, parallel corridors, accidents, speeds, pedestrians and bicyclists.

Steve Tracy and Sherryl Garrety, Old North Davis Neighborhood Association; Alan Miller and Tim Alice, Old East Davis Neighborhood Association; and Cindy Marshall spoke in support of a road diet/Complete Street proposal. Comments included: 35 accidents on Fifth/Russell between A and L Streets during 2007, safety needs to be a major priority, need for bicycle in the downtown, traffic speeds too high, and data gathering needs to be transparent

David Greenwald stated accident data understates safety issues.

Steve Greenfield, Davis Chamber of Commerce, stated Fifth Street is dangerous to cross for all modes of transportation, and access to downtown is paramount for businesses. Further, the Chamber opposes use of Redevelopment Agency funding for this project.

City Council provided input to staff on criteria to be used in guiding the development of alternatives. Comments included: protected turns on Fifth Street may need to be considered to improve cross lane traffic, all modes of transportation should be planned for, concern over potential tree removal, limit impacts to parallel corridors, concern over potential cost, and support bicycle connectivity throughout city.

D. Saylor moved, seconded by S. Souza, to approve the workplan and direct staff to return in April with a list of preliminary project options. Motion passed unanimously.

Council recessed at 10:13 p.m. and reconvened at 10:23 p.m. D. Saylor left the meeting at this time.

Consideration of Fiscal Year 2010 Federal Legislative and Funding Priorities Assistant City Manager Paul Navazio provided an update of staff efforts to identify short-term federal legislative and funding priorities in response to pending congressional federal appropriations request deadlines as well as regional efforts to coordinate submission of projects eligible for Federal Economic Stimulus funding.

- 1. Authorize the Mayor to submit necessary documents for Federal Appropriations requests and Federal Stimulus projects on behalf of the city, as well as letters of support for appropriations requests from other agencies

2. Direct staff to further develop long-term federal funding priorities, in conjunction with the city's long-range capital planning efforts, with the goal of enhancing the city's ability to secure future funding opportunities
