Public Comment

Jenifer Seger, Climate Action Team: 1000s of dollars available for energy upgrades through State of California; rebates and tax credits are available at www.energy.ca.gov; local grant information is also available.

Mark Framer and Richard Livingston spoke regarding an op-ed article in the Davis Enterprise. Comments included: Early on 4-26-11, armed immigration agents surrounded house, yelled, bashed door down and held guns to people; request Council direct Davis Police Department coordinate with Yolo Sheriff to propose to Department of Homeland Security that the next time they have a search warrant to execute it should be given to local officers to execute; Incident needs an investigation.

Billy Doughty, Davis Aquadarts, spoke regarding the recommendation to close Community pool. Comments included: Speaking on behalf Aquatic Council; want to put together proposal with City for new aquatic facility; bring all user groups into one multipurpose facility; raise capital through the user groups and bring revenue into downtown Davis; want to initiate conversation and be proactive early on to come up with solution for long term.

S. Greenwald requested a report from the Police Department regarding the event on April 26. City Attorney Harriet Steiner stated there is a possibility we won't get any more details. P. Navazio explained that this is an ongoing investigation that is outside of our jurisdiction, but will try to come up with information.

Public Hearing: Fiscal Year 2011/12 Proposed Changes to Fees and Charges P. Navazio explained that fees typically go along with budget proposal, but timing requires fees be set well before budget.

Interim Finance Director Sandra Sato summarized the FY2011/12 Proposed Changes to Fees and Charges, cost recovery goals, and fiscal impact of changes by department.

Mayor Pro Tempore Swanson opened the public hearing, and after no comments, closed the public hearing.

NOES: None ABSENT: Krovoza Budget Workshop: Overview of Fiscal Year 2011/12 Proposed Budget, Budget-Balancing Framework, Departmental Review-Proposed **Budget Recom**mendations and Service Level Impacts, Funding Recommendations Related to the City's Capital Improvement and Redevelopment Agency **Budgets**

Interim City Manager Paul Navazio and Budget Manager Kelly Fletcher summarized the proposed Tier 1, 2 and 3 reduction recommendations, budget-balancing measures, funding shifts, position reductions and general fund forecast for the next five years.

Public Comment:

- Nikhil Joshi, Civic Arts Commission: Civic arts contract program is listed in both Tier 1 and 2; Tier 1 proposal is to staff time allocated to the municipal art fund; fund is for art and will be depleted very fast; Tier 2 reduces Civic Arts Contract, good program, would be terrible if it had to be cut out completely.
- Doby Fleeman: Support transparency in government operations and financial reporting; how is the City or University exempt from facility replacement funds?; City is incapable of making full payment to pay off retire medical.
- David Greenwald: \$485,000 allocation in Tier 2 for infrastructure, not enough when unmet needs are approaching \$12 million; assumptions for employee compensation 5 years out is optimistic; need to determine spending priorities.

City Council recessed at 9:01 p.m. and reconvened at 9:15 p.m.

Department and program impacts were presented by K. Stachowicz, Police Chief Landy Black, Interim Fire Chief William Weisgerber, Interim Public Works Director Robert Clarke, Community Services Director Elvia Garcia-Ayala and Department of Community Development and Sustainability Director Ken Hiatt.

City Council comments included:

- Should be looking at the reserve amount
- Recurring expenditures versus single one-time expenditures is confusing to public
- Need to look at more structural changes
- Need to bargain with employee representatives before we go further into Tier 2
- Transportation needs to be included in incremental funding plan
- Want community to have input
