# 3. Neighborhood Court

Robb Davis, a citizen who has been working with the District Attorney's office on the Neighborhood Court initiated by the District Attorney, explained the DA's Office is trying to deal with the challenge of low level crimes given a shrinking budget. San Francisco has a similar program started a few years ago where 3 members of the community meet with the offender and determine a particular response for offender. The Yolo model has elements of restorative justice. Shared the written materials for concept paper (attached). Davis Police started handing out information/cards on Picnic Day to some offenders. DA's Office is still in process of trying to recruit panelists.

For victimless crimes, Yolo program will involve facilitator, offender, community representative(s). Yolo model will have a pre-conference discussion with offender and facilitator. Commission asked about metrics to gauge the effectiveness of the program. Snow noted that we should keep eye on the panelists to ensure that there is diversity of panelists. Davis noted there will also be a UC Davis program to match the program in the City.

Davis noted that the DA's Office is very concerned about protecting the victim(s). In Neighborhood Court, victim must be willing participant, as a key difference is involving victim. DA's Office wants the Deputy DA to be the go-between for victim and Community Representatives. Davis not sure where DA's Office will land in terms of how they proceed with Victim Crimes.
