## 6. Regular Items

#### A. Social Equity Indicators

The Commission continued discussion on Social Equity Indicators and discussed possible next steps, which may include recommended guidelines to City Staff for community outreach. While work in Oakland and other areas is something to strive for, that may be cost prohibitive at this time. What can be done that is more manageable? Review of surveys to ensure more equitable language, implicit bias training for staff, working with

young front line staff to find ways for them to provide comfortable space for program participants, etc.

## **B.** Holiday Celebrations

The Commission reviewed upcoming celebrations in the community and continued previous discussion on how holiday celebrations can be expanded upon and/or new celebrations to host. They landed on an idea to roll out a pilot year of cultural celebration grant funds, that would be available to cultural groups to assist in creating community wide celebrations. The grant format could be similar to the way the arts grants are allocated. Funds could be provided in a way that is equitable to funds spent on the annual holiday tree lighting.

O'Rourke-Powell moved with second by Clinton to request \$5000 for a pilot year of cultural celebration grant money using a format similar to the arts grants, with the funding intended to be similar to that of the holiday tree lighting celebration. The motion passed as follows:
