A. Discussion Related to Defining Community Health and Public Safety Improvements

At the July 23, 2020 Commission meeting, the Commission appointed a subcommittee to join the Police Accountability Commission and the Social Services Commission for discussion regarding the City Council's June 16 directive on community health and public safety. The subcommittee presented to the commission information from the first joint meeting and solicited feedback from the Human Relations Commission to bring forward.

This item will be going back to the City Council in late fall.

HRC message to subcommittee -

- Defining terms and language is important
- Build process is important. Maybe create similar process as to development of PAC
- Process to engage community, prioritize for identifying what is most relevant topics
- Review report from consultants from PAC creation could be starting point.
- Process, identify reoccurring themes, prioritize list, identify short and long term goals
- PD org chart will be helpful to see and have the various collaborations explained
- Memphis model could be a starting place to work on collaboration
- Yolo County Collaboration on Crisis Intervention and how it is moving forward
- Clear principal or value trying to achieve
- Identify what are problems and perceived problems
- OODA loop Obverse, Orient, Decide, Act and repeat
- Primary goal address racial disparities and structural racism

Public Comment:

- Robin R Impress upon people the terminology and how they are interpreted differently especially in response to the terms of public safety. Defining terminology is important. People often define public Safety as "Incarceration".
- Justine Gonzalez Would like Council to address students not being able to remove themselves from leases due to Covid 19.

B. Commission application process and outreach process implementation

Application Process:

- Make application less intimidating
- Less robust
- Is there possibility for stipends to encourage a more diverse applicant pool
- Use plain language
- Carrie/Kelly/Emma will have follow up meeting to identify areas that may be able to change on application

Recruitment and Outreach Piece:

- There is momentum with a drive to have a more diverse school board/could partner or conversation with them about efforts to getting the commission word out.
- Invite someone from group to come to future meeting
- Publicity encourage all types of publicity, expanding out of newspaper announcement, etc.
- Work to get commission application information out to varied groups.
