A. Public Forum on Recent Hate Incidents in the Davis Community

The Human Relations Commission provided an opportunity to discuss and receive public input on recent hate incidents in the Davis community.

- Recent event at the library speaker addressed issues around girls in sports and transgender athletes, organized by the Moms for Liberty organization. Newspaper reporting states that the event was shut down due to the library stating that the speaker was misgendering and that went against the library code of conduct.
- Bomb threat at the library the next day, with media documenting that there was derogatory commentary made in relation to it. News reporting that other libraries across the country have been targeted as well.
- How events are communicated is important. Not everyone gets their news and information the same way. Sharing of accurate information is important.
- Reference to the person in Southern California who was shot and killed for having a Pride flag in their window. Communications and messages that are put out there is important.
- Free speech is important, however when free speech was created, there were no protected classes. The goal of free speech is to create freedom and democracy and not a way to oppress people.
- Children's rights should also be centered.

 Dorte Jensen – Encourage commissioners to review Washington.com that has video posted from various angles. Bomb threats happen in the schools throughout the year as well, so may not be correlated.
