 - A. Public Hearing: Second Street Crossing, 4551- 4651 Second Street Target Pad Buildings: Planning Application #19-16, Rezone #1-19, Revised Final Planned Development #1-19, Development Agreement Amendment #1-19

Principal Planner Sherri Metzker: The Second Street Crossing project contains 46,000 sq. ft. divided among four pad buildings with specific allowable retail and ancillary uses. The requested modification would eliminate the minimum and maximum size requirements for permitted uses.

Chair Streeter opened the public hearing.

Cybil Bryant, Applicant: Increase flexibility of the space. Would like to get empty spaces leased out.

Chair Streeter closed the public hearing.

 - a. Ordinance Amending Section 40.01.090 of the City Zoning Ordinance by Amending Planned Development PD #10-04B to Revise the List of Approved Uses for the Second Street Crossing Project

 b. Ordinance Amending the Development Agreement By and Between the City of Davis, Target Corporation, and Second Street Crossing, LLC Relating to the Second Street Crossing Project

Motion passed unanimously.
