A. Planning Commission Minutes April 28, 2010

7. Public Hearings

A. PA #06-10, 1800 E. Eighth Street, Grocery Outlet Store, Public Convenience or Necessity #02-10; (*Cathy Camacho, Planner*)

Public Hearing to consider the City making a determination of public convenience or necessity in compliance with requirements of the California Department of Alcoholic Beverage Control for an off-sale beer/wine license for the Grocery Outlet store located at 1800 E. Eighth Street. The Grocery Outlet has proposed to be located at the former Albertson's/Ralph's Grocery store which sold beer and wine to their customers previously. The applicant states that beer and wine would be offered in approximately 447 square feet of the total 9,979 square feet of floor sales area. The Grocery Outlet does not intend to sell singles. The beer and wine area of the store would be carefully monitored both visually and with security cameras.

Mike Webb, Principal Planner, presented the staff report.

Commissioner Choudhuri opened the public hearing.

George Ramstead, Grocery Outlet Architect, said the census tract number is how the state comes up with the threshold of number of alcohol licenses. He answered questions from the Commissioners.

Commissioner Choudhuri closed the public hearing.

Commissioner Hofmann proposed an additional finding to be added. It read as follows: "Despite an overconcentration of licenses and the project's proximity to a large number of sensitive uses (e.g., schools, places of worship, etc.), issuance of this license will serve both the public convenience and necessity.

Specifically, issuance of this license type to this form of retail business (focusing on factors including hours of operation, product mix and retailer experience) is in furtherance of the public welfare and morals in that it will: 1) increase the long term economic viability of the neighborhood, 2) result in a net employment gain for the city, and 3) enhance the public utilization of the space and shopping center."

- Action: Commissioner Frerichs moved approval of the PCN with the suggested additional findings from Commissioner Hofmann as read into the record above including the typos as mentioned. Commissioner Whittier seconded the motion.
