

City of Davis Police Accountability Commission Minutes Monday, November 1, 2021

1. Call to Order and Roll Call

6. Police Auditor Update

Independent Police Auditor Michael Gennaco provided an update on Auditor activities to the PAC, including updates on legislation, current caseload and other projects.

- New legislation
 - o AB 48, SB 98 relate to protests
 - AB 481 relating to local governments' purchase and use of militarized equipment
 - AB 26 requires officers to intercede where excessive use of force occurs.
 Also addresses obligation to report and a prohibition against retaliation.
 - AB 1506 has State Attorney General taking jurisdiction over any office involved shooting involving the death of unarmed civilian.
 - o AB 490 extends prohibition against use of neck restraint
 - o SB 2 addresses de-certifying of officers after termination
 - o AB 89 increases age limit that officers can be hired to 21.
 - SB 16 expands public access to police personnel records
 - AB 958 participation in unlawful or unethical on duty behavior is grounds for termination and disclosure to further agencies.
- Commissioner Comments/Questions:
 - Will the information cross state lines on officer de-certification? (Only five states currently do not have certification system. National legislation would be required to address.)
 - AB 481 seems to apply to Federal Surplus property. (Second part of bill addresses new acquisitions.)
 - Is there anything retroactively that addresses officers being hired who have been terminated from other agencies? (Not retroactive)

7. Regular Items

A. Independent Police Auditor "8 Can't Wait" and Use of Force Audit Discussion – The Audit Outreach Subcommittee (Bliss, Horton, MacBrine, Poindexter) reported out during this item.

Subcommittee Comments

- Desire to have improved report for annual use of force report with greater detail, including successful use of de-escalation tactics.
- Policy states that there is tactical debrief after use of force. Would like additional details on debrief and documentation on scope of them.
- Have Use of Force report match categories of Use of Force policies.
- Recognize officers who are successful in de-escalation tactics.
- Increase Use of Force categories to include canine use, pointing a gun.

General Commission Comment

- Concern that data across agencies is not comparable, so comparing Davis' use of force to other communities is misleading.
- How many calls for mental health or substance use were successfully deescalated.
- Supports recommendations for improvement, including supervisory reporting
- Are there tools to classify lowest types of use of force?
- Curious about day to day operations and training sessions on Use of Force

- Would like Chief to come to PAC and share details of de-escalation and day to day policing, whether police will implement audit recommendations, and whether report was shared with department. Some commissioners interested in hearing directly from officers.
- Public meeting will likely happen in January

MacBrine moved with second by Horton that the PAC let the City Council know that the commission approves the Independent Police Auditor Use of Force Audit and will submit additional recommendations in the coming months. Motion passed as follows:

- Concern about the long term funding for the department
- People will still call 911. How will those be handled? Dispatch training on how to respond and who to send it to. Homeless Outreach Coordinator, etc.
- Would like to get more information as to why parking enforcement was left in the Police Department.

Public Comment:

- Connor Gorman Supports creation of new department. Would also like to move parking enforcement, redirect resources from police to other department, and have director should come from public health.
- Lupita Torres Encourage City Council to hire one Native American social worker, trained to work with youth. Urges training for social workers.
