

# City of Davis Police Accountability Commission Minutes Monday, January 10, 2022

# 1. Call to Order (6:30)

## 3. Brief Announcements from Staff, Commissioners, and Liaisons

- Stachowicz announced that the Martin Luther King Celebration will be moved to a virtual format over social media.
- This meeting is Commissioner MacBrine's last meeting. Gratitude is expressed to her for the last three years and being the first chair of the PAC.
- Horton paid tribute to Natalie Corona's service to the community on the three year anniversary of her killing.
- Horton paid tribute to the work of the officers on the one year anniversary of the January 6 attack on the capitol.

#### 4. Public Comment

 Connor Gorman – City Council approved additional budget for armed sworn police officers. Gorman is opposed to additional officers and use of additional funding for police. Lawsuit in City of Sacramento against their police department in civil rights violations.

## 6. Police Auditor Update

Independent Police Auditor Michael Gennaco provided an update on Auditor activities to the PAC.

Gennaco reviewed the Use of Policy in Davis suggested that there are two parts to consider reviewing.

- 1. Language is not definitive on if pointing a firearm is considered a use of force. Wondering if it should be more absolute.
- 2. Policy language is unclear as to if a police canine is used and the dog bites, is that considered use of force.

#### Commissioner Comments:

- Use of fire arm should be explicitly described as use of force
- Many commissioners indicate that it is important for commission to look at both of these areas and pursue as a commission
- · What are agency standards across the country?

#### Public Comment:

 Connor Gorman – Agree with commission consensus. Thinks that policing in general is use of force.

# 7. Regular Items

## A. Subcommittee Updates

1. Annual Independent Police Auditor Evaluation (Bliss, Canning, Sherman, Escamilla Greenwald) – The Subcommittee has reviewed the Independent Police Auditor's work with the Commission and has provided a draft set of topics for inclusion in a memo (attached in meeting packet) to approve and send to the City Council. Accomplishments and goals were addressed, along with goals not yet completed and a desire to move into the 2022 goals.

## Commissioner Comments:

- Do people decline to file a formal complaint after discussions with IPA? From Gennaco, all calls have resulted in follow up of some sort.
- Would like to see follow up on recommendations made to the police department that were not incorporated and reasons why.

3. Mental Health – Audits (Bliss, Canning, Escamilla Greenwald, MacBrine) – Subcommittee met with Independent Police Auditor Gennaco to discuss next steps with this proposed audit. The Subcommittee reported out on their work (details included in packet).

#### Commissioner Comments:

- Clarification that calls are identified as 5150 at the end of the call
- Is there concern about missing some of the suspected mental health cases or having them not identified as such?
- Distinction between mental health challenge and mental health crisis. Design of audit is towards crisis.
- 10 cases as identified seems like a good starting point.

- a. Local Voices Project The subcommittee was assigned to provide any follow up from the October presentation by Local Voices
- b. 8 Can't Wait Public Workshop In December, the Commission voted to hold a public workshop on the Use of Force (8 Can't Wait) Audit. Unless the Commission designates a subcommittee specific to the workshop, coordination would be provided by the Outreach Subcommittee.
- c. Bias by Proxy Public Workshop At the December meeting, the Commission asked the Outreach Subcommittee to look into hosting a Bias by Proxy Workshop.

Sherman suggests Escamilla-Greenwald as chair and Bliss as vice chair
Canning nominates himself as vice-chair

Bliss retracts acceptance of nomination to allow for other nominations

 Connor Gorman – Suggests that Canning or Poindexter would make good vice chair and supports consensus of commission

RE: Annual Evaluation of Independent Police Auditor

One of the PAC's charges is to evaluate the work of the Independent Police Auditor (IPA) with the Commission. The Commission approved this memo at its meeting of January 10, 2022 to serve as that review and is pleased to submit it to the City Council. Upon Council review and approval, the memo will be shared with the IPA. The Commission maintains a good working relationship with the IPA and is pleased to have this resource available to the community.

Accomplishments. We would first like to acknowledge accomplishments over this past year, one where we have continued to be challenged by the ongoing COVID-19 pandemic, remote meetings, and important discussions and policy decisions related to desired service delivery for public services. There are numerous accomplishments of the IPA to highlight, in addition to his regular attendance and participation in PAC meetings. Mr. Gennaco has been accessible, responsive and instructive to PAC members; has provided regular written monthly reports of caseloads, including feedback on whether Alternative Conflict Resolution has been utilized; and has provided updates on relevant legislative changes and their likely effects on policing and the community. He completed a thorough audit of use of force ("8 Can't Wait" and no knock warrants) with a written report and recommendations for the City Council/Police Department. Conversations have also begun about starting a second audit, focused on mental health responses.

Goals Continued into 2022. In 2021, the PAC considered a number of goals that involved both the PAC and the IPA. Of these, there are several goals that are recommended to be carried over into 2022. These include the following:

- Provide number and type of calls IPA received from community, allowing for greater understanding of types of calls to the IPA and the percentage that result in formal complaints about DPD
- Provide regular follow-up to PAC on past recommendations to DPD (from complaints and 8 Can't Wait + 1 Audit) to see if recommendations were adopted and if not, why not

- Develop standardized process with PAC for review of DPD policies allowing for comparisons to national Best Practices. (Was done in 8 Can't Wait Audit but an ongoing process for review was not completed)
- Assist with community outreach and participate as needed (not needed in Know Your Rights meeting and 8 Can't Wait audit meeting not held in 2021)

New Goals for 2022. In addition to the ongoing goals, the PAC would like to request working with the IPA on several new goals, outlined below:

- Complete 2<sup>nd</sup> DPD audit and report (mental health or other identified topic approved by PAC)
- · Participate in identified community outreach meetings, as needed
- Provide PAC with national policing best practices for PAC to use as benchmarks when reviewing identified DPD policies
- Provide regular follow-up of past recommendations to DPD (from complaints, use
  of force incidents and any audits) showing if accepted and/or implemented, or if
  not accepted, why not?
