7. Regular Items

A. Update on Mental Health Audit Request – Staff provided an update on the mental health audit request for information from the PAC to the Independent Police Auditor.

The release of information requested for the mental health audit is still under City attorney review, with a focus on privacy issues for individuals. The Commission asked why other jurisdictions are able to obtain the information, why the City Council has concerns, and why the City Council is discussing the issue. They request that the City Attorney take another look at the subject and requested a timeline on a response from the City attorney.

The Independent Police Auditor stated that on a previous 5150 case, the report was able to be written without identifying names or information. The mental health audit would be strictly to evaluate how the Davis Police Department responded to calls for service.

Public Comment:

 Connor Gorman – Supports having City Attorney part of this conversation at the next meeting. Closed session conversations should be determined.

Canning moved with second by Horton to submit questions regarding this topic (questions above and Commissioner Canning's written questions) to the PAC Council liaison to provide to City Attorney.

Poindexter provides a friendly amendment to request that Council use expertise of IPA Gennaco. Canning and Horton accept friendly amendment.

- B. Subcommittee Report on AB 481 and Use of Military Equipment Ordinance On April 19, the City Council introduced an ordinance pursuant to AB 481 to provide a process to allow use for specific types of equipment defined as military equipment. The commission subcommittee of Escamilla-Greenwald, Horton, and Sherman asked for commission feedback on the proposed ordinance. Commissioner feedback is summarized below:
 - Would like to see a similar process to public hearing process with first and second readings
 - Concern that enough time to be provided to commission and public for review, with opportunity to ask questions about use and disposal of specific devices
 - Clarify what ordinance does
 - Ordinance identifies pieces of equipment the City has
 - o If Ordinance adopted, City has approval to use that equipment
 - o If new equipment is desired, Council needs to approve in public process

 Ordinance requires an annual, public review that documents what was used and how it was used. Proposed for PAC to be a part of this.

Public Comment:

Connor Gorman – PAC should be involved in review of new items purchased. Review size needs to be manageable. Concern about militarization of police.

Poindexter moved with second by Jones to recommend that Council obtain usage data of each item used and have the Chief provide response prior to approval of ordinance.
