Vaitla confirmed that the Commission will be hosting a lecture on December 16, immediately prior to the Commission's regularly scheduled meeting. He explained the lecture will feature Senior Research and Policy Manager for J-PAL North America, Rohit Naimpally, who will

provide an overview of J-PAL's recent evidence review of effective strategies to reduce and prevent homelessness.
