# 6. Regular Items

### A. Presentation: Yolo Food Bank

Michael Bisch, Executive Director of Yolo Food Bank, shared a presentation about Senate Bill 1383, Edible Food Recovery Program. Bisch suggested that the City partner with Yolo Food bank in their citywide efforts to limit food waste and improve food recovery. Support from the commission was requested.

- Josh Chapman expressed support for the efforts of the Yolo Food Bank.

# Commission Discussion:

Commissioners discussed the feasibility of creating a city-mandated food recovery program. The cost would ultimately be passed on to the ratepayer. Mayor Brett Lee and former Mayor Robb Davis shared information about the City's previous exploration efforts into a food recovery program.

# B. Davis Homelessness Alliance Year One Progress Report

Martha Teeter and Joan Planell shared a presentation detailing Davis Homelessness Alliance's accomplishments in year one and goals for year two.

- Martha Teeter suggested utilizing funds for rental assistance.

Commissioners had a robust discussion about exploring funding sources, potential uses, and priorities of the housing funds.

Vaitla moved to have staff receive commission input and update the report before presenting to City Council, with a second by Perez. Valencia made a friendly amendment to the motion suggesting that a commission member present the report to City Council. Vaitla accepted the friendly amendment.
