Valencia discussed the Housing Element Update. Virtual workshop information. Valencia also shared that a couple of affordable homes appear at risk of losing the first right of refusal – 3205 Albany Terrace and 1115 Greene Terrace.

### 6. Regular Items

## A. Presentation: Substance Use Programs and Trends

Ian Evans shared presentation. Below is a summary of the programs that were discussed.

- Co-Responder Embedded Clinician model collaboration between City and County to respond to behavioral health or social service calls. Will also have Crisis Intervention Training.
- Crisis Now Initiative mental health services oversight and accountability commission funded. 8.5 month learning collaboration designed optimize behavioral health crisis response. Three core elements: crisis call centers coordinating in real time, centrally deployed 24/7, mobile crisis response teams, short-term "sub-acute" residential crisis stabilization programs.
- Systems of Care project funded by the state. Helps to assess provider teams and provide training to them. In late April bringing in providers to a two-day session to have goal setting.

Ennis and Valencia asked for clarification on various aspects of the programs.

#### Public Comments:

Martha Teeter – Asked what type of services are of highest need in Davis? Ian Evans discussed the ongoing need for substance use services and services alike in Davis.

### B. 2021 CDBG/HOME Funding Recommendations –

Kelly Stachowicz walked through the CDBG and HOME application process and grant applications before the commission. There is a total of \$1,153,792 to award

Valencia asked for clarification as to why certain organization had not applied for the current year. Stachowicz stated that administrative burdens outweighed the interest of certain groups and other groups simply did not apply.

#### Public Comments:

Alan Pryor of Davis Oral Health, stated that the City withholding \$5200 in funds from 2019-2020 year. Pryor also stated that the City's interpretation of the reporting requirements is onerous and draconian. Pryor believes that the process could be greatly streamlined. Pryor stated that a correction should be made to the recommendations spreadsheet for program 2020-2021 that should be corrected to zero out of zero recipients served.

#### Commission discussion:

Staff and Commissioners discussed the recommendations and questions were clarified. Minimal discussion ensued.

Wise moved, with a second by Kalman, to approve staff recommendation and to equally divide excess \$1258 among applicants.

- Aid Council and Social Services providers to meet needs of unhoused
- Preservation of affordable housing
- Social Services programs and activities through outreach

Proposed Objectives and Activities for the work plan:

- CDBG, HOME, Pathways
- Assist with Strategic Plan and Housing Element
- Inventory of ss orgs and activities
- Conduct surveys, focus groups to amend data re ss programs
- Raise awareness of issues related to Affordable Housing, food insecurity, child care access, seniors, citizens with disabilities, and the wider Davis community
- Collaborate with other commissions
- Educational opportunities
- Subcommittees

#### Public Comment:

Martha Teeter stated that the Davis Opportunity Village (DOVe) worked with City of Davis to create a 3-year plan regarding homelessness in conjunction with the Davis Homelessness Alliance. The plan is in its second year.

Stachowicz stated that the City has preferences on the way affordable homes are marketed.
