# **Opening Statement**

Welcome to the monthly meeting of the City of Davis' Tree Commission.

Members of the Tree Commission are all volunteers and appointed by the Davis City Council.

The Tree Commission provides leadership and guidance to the Urban Forest Manager and to the City Council regarding tree removal and replacement requests.

The Tree Commission provides for the protection, preservation, and enhancement of Davis' urban forest. The Tree Commission is charged to recommend the removal of a City tree on a case-by-case basis for the following reasons:

- Poor health, identifiable diseases, exceedingly slow growth, large scale limb failure and decay;
- Potential for hazardous conditions that are caused by the street tree and cannot be mitigated without the removal of the tree.

The Tree Commission does not have the authority to recommend the removal of a City Tree for its debris, such as leaves, fruit, nuts, pollen, pine cones, needles, etc., nor does it have the authority to recommend the removal of a tree for its potential as an allergen or for solar collector installation per Municipal Code Section 40.38.00. The Tree Commission does not have the authority to remove a tree if it is healthy.

All Tree Commission decisions can be appealed to the City Council for their consideration.

- Alan brought in acorns from the Canby Oak in the climate ready tree plot on the UC Davis campus.
- Reported the newly planted trees on the Covell bike path are not planted to City specifications and would like them checked for proper staking.
- Reported a hazard tree on private property at the intersection of 8<sup>th</sup> St. and Oak Ave.
- Commented that the enforcement sections of the ordinance update are the most important parts of the update.
- Parking lots need to be monitored by the City of Davis or a hired arborist by the City and funded by the developer.
- Urged the Commission to understand how the Downtown Plan, Tree Ordinance, and Form-Based Code work together.

# C. Tree Ordinance Update

The Commission discussed the progress of the ordinance update and agreed to review the final updated draft and proposed reformatted outline for the December Tree Commission meeting.

Two members, John Johnston and Hannah Safford, of the Natural Resources Commission (NRC) came to the meeting to relay information to the Tree Commission regarding the Cool Parking Lot document developed by the Natural Resources Commission. During public comment the commissioners made the following comments:

- The NRC has a greenhouse gas subcommittee looking into large parking lots in the future.
- They are following the City Council directive for the declared climate action emergency.
- The NRC wants to put forth a holistic approach to the designs of the parking lots for incorporation of the suggestions in the cool parking lot proposal.
- The NRC is proposing the addition of solar canopies as part of the shade calculations.
- The NRC is not proposing to replace trees with solar canopies in the parking lots for shading.
- The NRC is seeking to exchange information and to partner with the Tree Commission to help with the parking lot shade guidelines in the updated Tree Ordinance.

Commissioner Wyly commented that this is a good time to evaluate the Cool Parking Lot documents and possible incorporation into the updated Ordinance.

Both commissions may draft a resolution to form a 2x2 committee to work on the parking lot guidelines during the ordinance update.

### D. Shasta Memorial Grove MOU for Tree Davis

The Commission reviewed the proposed tree grove plan and approved the updates and turf conversions to make more room for tree planting and habitat improvements through planting native and drought tolerant trees and shrubs.

### E. Davis Downtown Plan

The Commission agreed to review the plan and form-based code plans and to bring comments to the December 19, 2019 Commission meeting.
