Opening Statement

Welcome to the monthly meeting of the City of Davis' Tree Commission.

Members of the Tree Commission are all volunteers and appointed by the Davis City Council.

The Tree Commission provides leadership and guidance to the Urban Forest Manager and to the City Council regarding tree removal and replacement requests.

The Tree Commission provides for the protection, preservation, and enhancement of Davis' urban forest. The Tree Commission is charged to recommend the removal of a City tree on a case-by-case basis for the following reasons:

- Poor health, identifiable diseases, exceedingly slow growth, large scale limb failure and decay;
- Potential for hazardous conditions that are caused by the street tree and cannot be mitigated without the removal of the tree.

The Tree Commission does not have the authority to recommend the removal of a City Tree for its debris, such as leaves, fruit, nuts, pollen, pine cones, needles, etc., nor does it have the authority to recommend the removal of a tree for its potential as an allergen or for solar collector installation per Municipal Code Section 40.38.00. The Tree Commission does not have the authority to remove a tree if it is healthy.

All Tree Commission decisions can be appealed to the City Council for their consideration.

Commissioner and Staff Comments:

Staff informed the Commission that Tree Davis will begin planting for the Cal-Fire Proposition 68 grant in October. They will begin planting in parks this year and will start at Baravetto Park on October 10th. This planting is a training planting for team leaders, who will lead future tree plantings for the grant.

Guenther thanked staff and the Commissioners for all the help with last month's meeting, especially with the Bretton Woods item.

Robinson asked about any wind damage from the recent high wind events.

Public Comments:

Alan Hirsch made the following public comments:

- I am requesting a cure and correct for the August minutes as the work plan item minutes has missing parts of the discussion.
- City Council approved the University Mall project with no tree mitigation. The trees were in
 poor condition due to poor maintenance and neglect. The project shows the lack of
 enforcement by the city for development agreements and no consequences for violations by
 developers.
- No construction protection for trees at projects throughout the city.
- Target is still in violation of parking lot standards. Trees are easy to plant but hard to establish.

Public Comment

Deborah Burnett made the following public comments:

- Against the tree removal at 1907 Alameda. I sent an email as well. I also sent a notification to next door. No obvious impacts to the house and cannot see type of damage being caused by the tree.
- The tree is a mid-block anchor and please read the email sent to the Commission.
- Reason for the tree removal is not stated on the notice. Advise the Commission to add this to the tree notice.

Dennis Wyss commented about the tree removal at 1905 Humboldt Avenue. He thanked staff with getting the item heard by the Commission and is in favor of having this tree removed so that his driveway can be repaired.

C. Work Plan Review

The Commission reviewed the draft 2020 work plan and agreed to take more time to review the plan and return the item to the October 15, 2020 meeting to finalize projects, assign projects and determine the timelines for the projects.

Commissioners discussed:

- Adding some public education projects
- Investigating possible joint commission meetings with the Natural Resources Commission and the Open Space and Habitat Commission
- Investigating the potential for a Tree Commission Face Book page
- Continuing the partnership with Tree Davis

The Commissioners directed staff to investigate the possibility to have 2x2 meeting with the Natural Resources Commission regarding the parking lot shade guidelines for the tree ordinance and with the Open Space and Habitat Commission to discuss native plant use for tree plantings.

Commissioners thought it important to continue seeking involvement with the community and other special interest groups to increase the awareness about the community forest and its care.

Commissioners directed staff to update the work plan with the added projects and to assign rankings to the projects for importance of taking on the projects.

Public Comment

Alan Hirsch made the following public comments:

- Commissioners should ask themselves as a volunteer what can I do.
- Changes come through the policy and oversight by the Commission and it should be taken as serious as the weed ordinance.
- There is lack of oversight of the development agreements within the city and not pushed to enforce the agreements.
- Commission should focus on accountability and enforceability of policies.

D. Tree Commission Appointments

The Commission discussed the possibility of gaining the ability to appoint interim Commissioners when vacancies arise prior to City Council commission appointments.

Commissioners discussed the process for getting this authority granted from City Council and what the process would be for the interim appointments.

The possibility of granting interim appointments after three months of a vacancy was one option suggested and then after a six-month vacancy, the interim commissioner would be made a regular member with City Council having the authority to remove during the regular commission appointment cycle.

Commissioners concerned as the Tree Commission currently has three vacancies and appointment will not be made until January.

The Commission also suggested City Council make commission appointments two times per year instead of the current once a year cycle.

City Council Liaison Partida commented that the City Council would have an opinion on the item and suggested staff contact the City Clerk about the rules and process for allowing Commissions to make their own interim appointments.

Partida also commented that City Council can recommence commission appointments if needed to fill commission seats if the commission cannot function with the current vacancies.

Public Comment

No public comment was given for this item.

A motion was made by Guenther to direct staff to request information for the possibility of giving Commissions authority to appoint interim Commissioners between times when the seat becomes vacant and the City Council makes commission appointments.

Public Comment:

Alan Hirsch commented that the Commission should be sent the draft ordinance as soon as possible and that the enforcement of the ordinance is of the utmost importance. This is a once in a generation chance to change the ordinance.
