

# REQUEST FOR PROPOSAL Public Art Opportunity

## City of Davis Seeks Public Artist For Russell Boulevard Green Street Demonstration Project

The City of Davis Civic Arts Commission is seeking an artist or collaborative team to thoughtfully design and create artwork that can be integrated into the existing plans for the Russell Boulevard Green Street Demonstration Project that will surround Davis City Hall at 23 Russell Boulevard. This project aims to showcase the effectiveness and beauty of sustainable landscape design for the community, serving as a green street model. Specifically, artists are asked to propose artwork to adorn the faces of six planned concrete seat cubes, each measuring 2' by 2'. Artwork should reflect sustainability, greening-related themes, local flora and fauna, history of place, and/or the architectural themes of City Hall.

The artist will complete works to be installed either on top of, or in recessed spaces on top of, the faces of six concrete seat cubes. Specific examples of work the Commission may consider include, but are not limited to the following:

- Mosaic glass, tile, or stone panels
- Ceramic tile squares
- Artfully arranged items encased in weather-resistant resin
- Other media TBD by artist

It is highly recommended that artists visit the site in person prior to design to better envision the project. Please also review the plans included in this document.

**The selected artist or team will be awarded \$6,000 to complete the project.** This amount must cover all costs, including artist fee, materials, and artist insurance.

## **Specifications for Artwork**

• Approximate measurements: There are 6 seat cubes, each measuring 2'x2'x1.5' tall with five available faces that can be vehicles/pedestals for art. Please refer to landscape design plans for more detailed measurements. Paver area around seat cubes is approximately 450 square feet.

- Completed artwork should have a smooth surface appropriate for sitting on, and should be void of any sharp surfaces.
- Only durable materials may be used in the creation of the artwork. Media should be weather-proof for sustained outdoor exposure.
- Artist must supply their own materials and media for production of proposed artwork.
- Drop cloths should be used at all times while painting and/or installing art on-site.
- Design may not include a copyrighted or trademarked image and must be an original created design by the artist or team of artists submitting.
- Artists are responsible for protecting their work from the elements and possible vandalism by selecting durable, weatherproof media and a design that does not allow for work to be easily removed from seat tops.

#### **Russell Greening Project Details**

In December 2017, the California Natural Resources Agency awarded the City an Urban Rivers grant to transform the Russell Boulevard frontage of City Hall with a green redesign. The project, deemed the Russell Boulevard Green Street Demonstration Project, will retrofit the area surrounding City Hall with various green infrastructure techniques. Specifically, project components will include:


- Conversion of 23,000 square feet of turf to drought-tolerant landscaping
- Rain gardens (landscaping watered by runoff)
- Eight planters to capture storm water
- Installation of a vegetated swale along Russell Boulevard to control and filter water runoff
- Two green walls to hide HVAC equipment
- Two plazas with permeable paving, shaded seating, and interpretive signs
- New pedestrian pathways using decomposed granite
- Permeable, ADA-compliant walkways to replace concrete walkways
- ADA-accessible boardwalk
- Six parking spaces with permeable paving

#### Candidate Plant List

The following plant species may be incorporated into plantings around the City Hall during the project. Final plant selections will be made during the final design phase, and may be considered for inclusion into artistic design if desired by artist:





#### **Selection Process**

The Davis City Council has charged the Civic Arts Commission with responsibility for recommending all acquisitions of public art. A panel made up of Civic Arts Commissioners, members of the public, and additional city staff members will oversee the selection process. The selection panel will review proposals and forward a recommendation to the Civic Arts Commission, then City Council, who has final authority for commissioning all works of art. As in all competitions, the city reserves the right to revise the project parameters as needed, and to reject all proposals if no consensus is reached on final selection.

The panel will review all application materials and choose the finalist. Selection will be based on a review of each applicant's style, examples of previous work, and ideas included with the preliminary sketch. Previous experience with public or private commissions is desirable, but not essential.

Finalists may be invited to present their proposals to the Selection Committee and answer questions as needed. Additional discussions with individual applicants may be held before the final decision is made.

#### <u>Timeline</u>

The schedule is contingent upon the City's project schedule and may be changed at any time.

Interested applicants wishing to respond to this Request for Proposal must submit all of the following. **Please submit application as a single PDF file** via email or on a flash drive or disc:

- 1. Sketches/graphics and description of your original design concept for the project.
- 2. Up to 10 images of recent art work. Please use high resolution and easily readable file formats (jpeg, pdf).
- 3. Image list indicating information about each artwork including the title of work, media, size, location, and artist fee received (if applicable).

4. Current resume, no more than four pages with your name, address, phone number, and email address at the top of each page. Please include names and phone numbers of up to three professional references who can address your ability to complete a public art project.
