SUBJECT: Projects for Existing City Facilities and Structures

Attached, please find project descriptions regarding how the City can rehabilitate its existing facilities and structures. As directed, staff used criteria that included: saving money, rehabilitating existing structures or facilities, creating no new facilities, maintaining the City's current level of service, and recognizing that the City does not have adequate funding to provide new services.

Project/Greenbelt Water Conservation Project - Due to an increase in water costs and ongoing sustainability efforts, the City of Davis is in the process of reducing its potable water use for parks, greenbelts, and open space areas with the goals of providing effective water management and controlling costs.

The City has developed its water management strategy into a five year CIP, which includes immediate, short-term and long-term recommendations. The City will be completing year one of the five year process this fiscal year, and an additional \$500,000 is being proposed to be included in FY 2014/2015 budget. Staff is recommending continuing the \$500,000 for the next three years of the CIP and providing an additional \$100,000 per year to continue with water management changes. Total cost of the project is projected to be \$3.2 million-.

Refurbish City Pools - Community and Civic Pools are in need of renovation. Both Civic and Community pools have not had a major renovation in many years and both have structural issues that need to be addressed. If the City is only considering refurbishing existing facilities and not adding upgrades, such as a 50 meter pool complex, then the issues at both Civic and Community Pools will need to be addressed in order to accommodate the current pool user groups. Total cost for refurbishing both pools is estimated at \$7 million.

Renovate, Rehabilitate Existing Parks - As part of the recent Parks and facilities Master Plan update, the City prepared an inventory of all hardscape elements in the parks including buildings, parking, tables, benches, playing courts, ADA issue, ball-field lighting, etc. As part of the inventory the conditions of the various elements were assessed and the estimated remaining useful life of the element was identified. Because many of these elements are part of parks, and

not facilities, they are not included in the City's Facilities Replacement Fund. Park maintenance staff has identified numerous pieces of hardscape in various parks in need of replacement, including fencing, backstops, picnic table, etc. The City currently has 65 play structures (in parks and greenbelts). The average lifespan of a play structure is 15 years (based on combination of wear and tear and compliance standards). Currently, 23 playgrounds need to be replaced based on current age over 15 years or compliance issues. Replacements of play structures average approximately \$300,000 each, and shade structures are approximately \$150,000 each. Staff is projecting allocating \$ 16 million to this project.

ADA Upgrades in Parks – This is an ongoing project which uses CDBG money to remove architectural and physical barriers and improve accessibility of parks and facilities in compliance with Americans with Disabilities Act (ADA) regulations. As part of the Parks and Facilities Master Plan Update an ADA assessment was conducted of the City's parks and facilities. On an annual basis the City attempts to correct as many ADA related items as possible. In addition, the CDBG money is used to help fund playground replacement and construct new ADA compliant restrooms. The CDBG program has its own process for identifying projects and review by the Social Services Commission. Staff is projecting allocating \$3 million to this project to help address ADA issues that cannot be addressed with limited CDBG money.

Tennis courts - All tennis courts are in need of resurfacing. Tennis courts are supposed to be resurfaced every 7 years. All City owned courts are past that age and showing significant deterioration of the surface. Walnut Park tennis courts need a major renovation and is at the top of the list in terms of need. 2nd highest priority are the courts at Pioneer Park because they have major cracks. Staff's current estimate is about \$800,000 to repair walnut court, but it could be higher if the lighting needs to be relocated as part of the needed repair work. Staff is projecting allocating \$800,000 to repair Walnut, and an additional \$2 million for all other court resurfacing.

Veteran's Memorial Center Rehabilitation/Modernization - A CIP for \$1,400,000 is proposed to be included in the FY 2014/2015 budget to address the start of the project to convert the Veteran's Memorial Center into a new multi-use facility capable of hosting teen programming, as was directed by Council in October 2011. The cost of the rehabilitation as projected by the Veteran's Feasibility Study that was completed in 2012 was between \$3 million and \$8 million.

Senior Center Rehabilitation/Modernization - Staff is recommending updating the older portion of the Senior Center to allow for additional programming and rental opportunities. Other than the addition of the Valente wing, the original portion of the Senior Center has not been updated since it was built in the 1980's. Staff is requesting allocating an additional \$7 million towards this project.

Replace Fountain at Central Park - The current water feature at Central Park is no longer functional. It is estimated that the replacement of the feature would be approximately \$1,000,000.

Below is a listing of projects that have not been included on the list. Adding any of these projects would require a cut equal to the amount of the additional project to a project listed above.

50 Meter Community Pool - As part of the Parks and Recreation Facilities Master Plan Update, the City Council authorized staff to move forward with a Feasibility Study for Community Pool in order to have more detailed information about the cost-benefit analysis for either a 50 meter competitive pool complex or that of a multi-use, recreational complex. In January 2012, the City retained the services of Aquatic Design Group to assess both the physical and financial viability of a newly renovated facility at Community Park. This public process was conducted from April through September 2012, and resulted in three site options being analyzed. Option 1 includes a 25 yard x 50 meter competition pool to be used primarily for competitive swimming, diving, water polo and/or synchronized swimming and a 6 lane warm-up pool. Option 2 includes a 25 yard x 35 meter competition pool with a recreational activity pool and splash pad, and Option 3 includes an activity pool, water-slides and other recreational aquatic amenities.

Through additional follow up meetings with the pool groups, the 50 meter pool with a 6 lane warm up pool option is the only option being considered at this time. This is also the only option that can also accommodate the current usage at both Community and Civic Pools combined and could result in the closing of Civic Pool. If a 50 meter pool is not built, and Civic Pool is not closed, then Civic Pool needs an estimated \$3 million renovation as listed above. Estimated costs for the 50 meter pool, warm up pool and additional structures at the Community Pool Complex is approximately \$10 million dollars, which is \$3,000,000 over the amount proposed for the refurbishment of both pools.

Sports Park set aside – The City has studied three locations for a Sports Park. The concept for the Sports Park is to provide land and entitlements that allow the youth sports groups to construct and operate their own fields. Many years ago a feasibility study was prepared to look at the fiscal costs of such a project. The project would include developing a 100 acre park (50 developed now/50 set aside for future growth), multiple field Sports Park to include additional youth soccer fields, lacrosse fields, rugby fields, softball field and baseball field with parking lots, restrooms, concession area, night lighting and other support facilities. Proposed cost for the project would be \$2,000,000.

New Dog Park set aside – Dog owner representatives were very active in the Updated Parks and Facilities Master Plan process and it continues to be discussed at the Parks and Recreation Commission. They have indicated a willingness to partner with the City for a second year-round fenced dog park. A major obstacle for this project will be to find a location that does not impact surrounding uses. Toad Hollow Dog Park and existing dog exercise areas are very popular. Toad Hollow in particular generates many vehicles and an estimated 125 visitors per day. The project

will likely require user fees, partnership agreements or ongoing assessments to offset the maintenance, operation and staffing costs. Proposed cost for the project would be \$1,000,000.

Bike Pump Track - As part of the City of Davis Beyond Platinum Bicycle Action Plan there was a recommendation to create a bike track specifically for BMX and mountain bikes. Proposed cost for the project would be \$1,500,000.

Add new Community Garden – There are approximately 50-60 people on the waiting list for the existing Community Garden. As the public becomes more aware of sustainability issues and understanding where their food comes from it is expected that there will be more and continued interest in gardening. A site for the new garden has not been determined. Proposed cost for the project would be \$750,000.

Value Added City Improvements -As part of the update to the City's Parks and Facilities Master Plan, additional projects were included to add value to the City of Davis. The list includes: Develop an outdoor exercise park, add Frisbee golf course along Covell greenbelt, add a lighted full size basketball court, expand E Street Plaza, create a Natural Adventure play park, convert a uncovered reservable picnic area to covered one similar the one in Mace Ranch Park. Staff does not have a cost associated with these projects. Some of these projects can be incorporated into the rehab and rehabilitation of City parks.
