Increase opportunities to gather information Increased reporting = increased information gathering opportunities Build our knowledge of potential high-risk locations / subjects

Definitions

Minimal Disclosure

Facts and circumstances about a reported incident required to determine whether a crime occurred, jurisdiction, and initial response priorities. Victim's identifying & contact info

- Time/date/location
- · Identity of suspect(s)
- Identity of potential witness(es)
- · Basic description of crime

Violence Against Women Act (VAWA)

VAWA mandates a sexual assault survivor – 12 years of age & older – who requests an evidentiary examination, must be offered an examination including when the survivor declines to cooperate with law enforcement.

VAWA exams can be requested

- at:
- · A law enforcement agency
- · A medical facility
- · A survivor advocacy center

Initial Response – Patrol Division

Initial Priorities

- Contact the survivor
- Address safety/immediate medical concerns
- · Secure the scene
- Secure witnesses
- · Secure suspect (?)

- Protect evidence
 - · On the survivor
 - · At the scene
- · Secure video
- Neighborhood canvass
- Preserve, summarize, and log dispatch recordings into evidence.

Survivor Contact

- · Obtain minimal disclosure
- With survivor consent, facilitate a meeting with advocacy.
- Evaluate whether an evidentiary examination should be sought.
- If so, facilitate the evidentiary exam see page 12

Considerations

- Treat the survivor with empathy, respect, and dignity.
- · Record survivor interviews
 - · Seek consent
 - · Audio vs. video
- · Use trauma-informed interview practices
- Provide written notification of rights document in report.
 - · Brochure, officer name, and case number.

Initial Response – Patrol Division

Considerations

- · Is an emergency protective order (EPO) appropriate?
 - Stranger vs. non-stranger sexual assault.
- EPO procedure found in PP 2-14-A: Section II, J, 6.
- · Reasons
 - Victim in immediate danger of domestic violence.
 - · Child in immediate danger of abuse by family/household member.
 - Child in immediate danger of being abducted by parent/relative.
 - Elder/dependent adult in immediate danger of abuse.
 Victim in immediate danger of stalking.

Initial Response – Patrol Division

Considerations

- · EPO's
 - PP 2.14-A,II,J,6,c: When an officer responds to an incident of domestic violence
 and reasonable grounds exist to believe the person is in immediate and present
 danger, the officer shall advise the person of the availability of an emergency
 protective order. An officer shall request an emergency protective order if the officer
 believes that a person who is eligible to receive an order is in immediate and present
 danger (FC \$6275(b)).
 - Fill out Form EPO-001, contact the judge.
 - Copy to: protected, restrained, Dispatch for CLETS entry, issuing Court.
 - Document in report.

Report Documentation If you did something, document it.

General Considerations

- Do not sanitize the victim's language.
- Note whether body-worn camera or digital audio recordings exist in the report.
- Document observations of impairment.

Report Documentation If you did something, document it.

General Considerations

- Thorough narrative documentation:
 - Demeanor of suspects and victims.
 - Sign of physical injury of suspects and victims.
 - · Consider photographs of both

Victim Advocacy

DPD

- Survivor gets to choose involvement level of advocacy
- Advocates provide assistance with <u>many</u> tasks
 - RO's, CalVCB, other criminal and civil processes

Victim Advocacy

Someone in the survivor's corner

"An advocate can be helpful now and in the future. If it is okay with you, I can ask an advocate to come meet us. You can decide if you want their assistance after speaking with them."

Trauma-informed interview practices can assist in obtaining information

CENTRAL

- · Start with the memories VS.
- · Sensory-based questions
- · Emotions and thoughts

peripheral

Trauma-informed interviewing

- Avoid interruption
- Avoid leading questions
- Avoid sequencing
- Avoid sharing personal information
- Show empathy
- · Be patient
- Use open-ended questions
- · Use the interviewee's language

Reporting Options Intelligence gathering opportunities Partial Investigation • More investigation than Information Only Reports • Not a Complete Investigation • Reported suspect is only entered as "Mentioned" subject in RIMS, unless a Complete investigation is completed. • Allows a survivor to proceed with an investigation at their preferred pace.

Reporting Options Intelligence gathering opportunities Complete Investigation Necessary investigative steps to send the case to the DA have been completed. Case is sent to the DA with the consent of the survivor. Reported suspect changed to "Suspect" in RIMS.

Reporting Options

Intelligence gathering opportunities

Blind (Anonymous) Reporting

- Anonymous Reports may be made by anyone, regardless of their association to the case.
- Pull a case number for a Miscellaneous Service Report (MSR) with the title "Anonymous Sexual Assault Report."
- Document what you are told. Respect the RP's desire to be anonymous.
- No investigative action will be taken. Disposition the case as "information only."

- Investigation into prior instances of similar conduct.
- Review and summarize local crime reports detailing prior instances of suspected sexual assault or violence.
- Conduct an NCIC Offline Search (refer to page 19).
