Special Inspection Procedures

- 1. The approved special inspection firm shall notify the Building Division office prior to the start of inspection duties.
- 2. Notification shall consist of job address, permit number, name of inspection agency, persons involved with inspection work at the job site, and the type of inspections to be performed.
- 3. The special inspector shall use plans and specifications approved by the Building Division.
- 4. Progress reports describing tests and inspections performed, nonconforming work discovered, and any actions taken to correct nonconforming work shall be submitted to the Building Division for documentation and review. All inspection reports shall be signed by the special inspector and the project engineer/ architect if any actions taken by the engineer/ architect are included in the report. All uncorrected deviations from plans or specifications shall be noted on the report. Copies of all laboratory reports shall be available to the Building Division upon request.
- 5. It shall be the responsibility of the contractor to give timely notice to the inspection agency so that the required services may be performed.
- 6. Inspections shall be carried out in accordance with all job drawings and specifications. It will be the inspector's responsibility to use adequate and proper methods of testing. The Building Division retains the option of reviewing and rejecting any test procedures found to be insufficient or inaccurate.
- 7. Only testing laboratory personnel shall take samples and transport them to their laboratory.
- 8. The special inspector shall consult the Building Official on problems or concerns over the work.
- 9. Final notification to the Building Division by the special inspection agency shall be submitted stating that all inspection duties as outlined in the "Structural Tests and Inspections Schedules" have been completed and all nonconforming work and resolutions thereof have been addressed. Any required items not inspected shall be noted, accompanied by an explanation as to why such inspections were not performed. This report must be complete and submitted to the Building Division for review before a certificate of occupancy can be issued. This report shall be wet signed and stamped by the project engineer/ architect of record and also signed by a licensed engineer responsible for the special inspection.
