Chapter 2. Public Review of the Draft EIR

PUBLIC REVIEW PROCESS

The public review period for the draft EIR began on January 7, 2000, and ended on March 13, 2000, covering the CEQA-mandated 45-day public review period and an additional 18-day review period. Copies of the draft EIR were mailed directly to numerous agencies and organizations for their review. In addition, copies of the draft EIR were also available for review at the City of Davis Planning and Building Department and at the Davis Branch of the Yolo County Library.

LIST OF PUBLIC AGENCIES, ORGANIZATIONS, AND PERSONS COMMENTING ON THE DRAFT EIR

The public agencies, organizations, and individuals that submitted comments on the draft EIR through March 13, 2000, are listed below in Table 2-1. Each comment letter has been designated by a number that will be used to refer to particular comments. Aside from the courtesy statements, introductions, closings, and attachments, the text of each letter has been divided into individual comments. Brackets and identification numbers in the right margin of each letter delineate each comment. Following each letter are the responses associated with that letter. Each response is preceded by a number that corresponds to the comment identified on the original letter. An asterisk (*) following a response number indicates that a modification has been made to the draft EIR in response to this comment. These modifications are presented in Chapter 4 of this document.
