

#### **ARPA Requirements**

- The City has received ½ of the funds and expects to receive the second ½ by May 2022
- Funds must be encumbered by December 2024 (and fully spent by December 2026)
- The City must report to the US Department of Treasury how the funds were spent, including all funds taken as revenue loss
