SUBJECT: G Street Activation Update on Community Engagement and Parking

Modifications, CIP No. ET0029

### Recommendations

1. Receive a staff update on the G Street Activation project, including the results of community engagement; and

- 2. Provide direction on what design elements to include in final design and direct staff to proceed with design; and
- 3. Direct staff to initiate development of a Civic Arts mural or other civic art feature to be incorporated along with identification of funding; and
- 4. Direct staff to initiate discussions with local community-based organization(s) to facilitate possible additional enhancements for G Street; and
- 5. Approve staff recommendations for parking plans between 3<sup>rd</sup> Street and 5<sup>th</sup> Street and between 2<sup>nd</sup> Street and H Street parking lot driveway.

### **Fiscal Impact**

The City is using American Rescue Plan Act funds allocated by City Council. There is approximately \$1,057,400 allocated for this project. Depending on City Council's direction for which project components they would like to fund, there could be a need for additional project funding. The staff-recommended improvements of platforms, fencing/barriers/planters, and decorative lighting can be achieved with the allocated funding for construction in 2024. Additional amenities, such as public art, entry archway, additional street light poles, and longer-term street infrastructure improvements will require future City funding, grants, or partnerships to pursue.

### Council Goal(s)

While this action does not support a specific task, it does support the City Council's Goal to Enhance a Vibrant Downtown and Thriving Neighborhoods.

### **Commission Input**

The proposed G Street parking modifications were presented to the Bicycling, Transportation and Street Safety Commission (BTSSC) at their February and June meetings in 2023.

Between 2<sup>nd</sup> Street and the H Street parking lot, the BTSSC preferred the road be made one way heading north and include a Class IV bikeway, with the elimination of parking on the westside. They also requested planters and bike parking be added to the westside of the street.

For the section between 3<sup>rd</sup> Street and 5<sup>th</sup> Street, the BTSSC expressed concerns about the additional angled parking causing conflicts between cyclists and backing vehicles and recommended that the angled parking only be established on one side of the street and the side that is selected should maximize the available parking. The BTSSC felt that the additional travel lane width would reduce the potential for these conflicts and make it easier for vehicles backing out of these spaces.

BTSSC commissioners were invited to the in-person community meeting and encouraged to participate in the online survey.

What about, no commissions provided input on the activation concepts, layouts or survey.

### **Background and Analysis**

Since June 2020, G Street, between 2nd and 3rd Streets, has been closed to motor vehicles and open to businesses setting up outdoor dining spaces, public spaces and to pedestrians and bicyclists. The decision to close G Street to motor vehicles was a collaboration between the City and businesses impacted by the COVID-19 restrictions. The intent was to encourage people to return downtown to shop, eat, and experience a positive community in a safe, socially distanced, outdoor setting.

The City and businesses transformed G Street quickly from a street for cars, into a street for businesses to expand into the street, where people can walk and bike. Since then, a desire to better organize, decorate and activate this area has risen, along with addressing concerns raised by the business community.

In January 2023, the City Council approved keeping G Street closed to motor vehicles. As a result of this action, City staff was asked to develop a list of near-term, mid-term and long-term alternatives to help enhance and activate G Street. To help develop the next phase of G Street, the City hired PSOMAS, an engineering consulting firm, to provide planning, landscape architecture and preliminary engineering services.

At the project kick-off meeting staff shared project constraints and deliverables with PSOMAS to direct their design proposal. Below is the list of shared constraints and deliverables:

- 1. The project budget is approximately \$1,057,400 and based on the cost estimate, the City hopes to provide a platform, fencing, planters, benches and lighting along both sides of the street.
- 2. The existing roadway is crowned and in some areas the middle of the roadway is higher than the sidewalk. As a result, placing street furniture directly on the

roadway would result in furniture sitting on an uneven surface. To create an outdoor space that is universally accessible, staff is considering constructing a platform that extends from the sidewalk into the street to create a flat area. Staff is proposing the City pay for and construct the platform to ensure continuity in layout, design, safety, and ADA access compliance.

- 3. The Davis Fire Department needs a 20-foot-wide clear lane along the project area.
- 4. To provide opportunities for local businesses to provide services that the community has asked for; such as outdoor dining.
- 5. Staff shared the community desire for providing public spaces for people to spend time with friends and family outside of the spaces defined for businesses.
- 6. Staff shared the need to develop design guidelines and a process for leasing the outdoor space.

In fall 2023, PSOMAS developed two design concepts and layouts to share with our community. Staff engaged with the community in three ways. We hosted an in-person community meeting on G Street where more than 200 people provided their thoughts on various layouts and designs. Following the in-person meeting, the City launched a city-wide survey with over 500 responses. Both community engagement activities included the same questions and materials where staff asked about five topic areas. The City also created a project website where community members could email staff with comments. Staff notes that during the in-person community event a private architectural firm (Design M Group) was also on G Street presenting concepts that they had developed. Staff did not include the Design M design option in the citywide survey. However, staff has included costs for entry arch that their proposal included in the cost menu below.

Below are the 5 topic areas staff solicited community feedback on and engagement responses. See Attachment 1 for comprehensive survey results.

### 5 Areas of Engagement and What We Heard

1. Design concept, preference for more business space or public space.

We asked respondents to select their preferred design concept. The two design concepts had different sized platform widths and public space area widths. The platforms would serve as outdoor business-lease space or public space depending on the businesses lease the space in front of their business. The length of the platform and locations of the platforms remained the same for each concept. Concept A had a larger platform width of 17.75' and smaller shared public space was 20.5'. In comparisons, Concept B had a smaller platform width

of 13.75' and larger shared use space of 29'. Both concepts met the fire lane requirements.

### What We Heard

Overwhelmingly, community members supported Concept A, where the business space was maximized. Over 70% (359 people) of survey respondents preferred Concept A. At the in-person meeting, we heard that Concept B was not enough space for restaurants to consider using the space for outdoor dining/retail. We also heard that one business hosts an event on G Street and that adding a platform would interfere with their event. There was also a desire to make space for food trucks and create a flexible space. Both options would allow for the activation of the street for these temporary events by utilizing the fire lane.

Staff spoke to several community members during the in-person meeting about the existing asphalt conditions and potholes. We heard from community members that they did not want a platform and instead they would like the City of fix the asphalt and reconstruct the roadway to reduce the street crown. There was also strong interest in spending the funds on repairing the sidewalk.

At the in-person meeting, we also heard support of the Design M concept, where people walked in the street and the sidewalks were used for dining and retail outdoor space.

### 2. Platform layout, preference of rectangular or triangular platforms

We asked respondents to provide their preference on the angle of the platforms. The angle of the platforms can impact the shape and feel of the space. We shared two design layouts. In Layout 1 the platforms were rectangular shaped, with right angles and in Layout 2 the platforms were triangular shaped. Layout 1 is less complicated to construct, but could be considered monotonous and create a visual platform tunnel. In Layout 2 the platforms could be considered more visually interesting compared to right angles. The triangle spaces in Layout 2 maximizes the platform space in comparison to Layout 1.

### What we Heard

The survey results showed that Layout 2 was the preferred platform layout with 56% of respondents preferring the triangular layout design. At the in-person meeting there was also more support for Layout 2.

# 3. Design style and design guidelines, preference of the style and color of furnishings.

Respondents were asked to provide their thoughts on a preferred design theme for the style of City provided furnishings, including the platforms, fencing, planters, benches and lighting. The design themes were, clean and modern, comfortable and traditional, and crisp contemporary.

To help draft the design guidelines, staff also asked respondents if they preferred that the business-provided furnishings, including tables, chairs and umbrellas were uniform, where every business had the same style and color of outdoor furnishings or a variety of styles and colors.

### What we Heard

Results from the online survey showed that 41% of respondents preferred the comfortable and traditional design theme. At the in-person meeting respondents preferred both the comfortable and traditional theme and crisp contemporary. At both the in-person meeting and the survey, clean and modern design had the fewest votes. At the in-person meeting, two commenters noted that the clean and modern design did not fit with the rest of the existing downtown Davis design.

We heard at the in-person meeting that some respondents did not want planters due to maintenance concerns. Several people noted the importance of comfortable benches with backs and the desire for lots of seating. There were several comments about the benches not being designed to be anti-homeless. One comment noted that market twinkle lights are a maintenance issue.

Overwhelmingly at both the in-person meeting and the survey, people wanted a variety of colors and styles of business furnishings. Over 75% of those surveyed voted for a variety of styles for business-provided furnishings.

### 4. Public space amenities, public art, naming this area

Participants voted on what public amenities they would like to see included in this project. The list of amenities included, Information kiosks, comfortable benches, musical engagement, kid-friendly play structures, large table games, modular seating and planters, modular swings, drinking fountains, flexible seating, public information, floor games, stages, and small table games.

Respondents were also asked to provide feedback on the color palette and style of a proposed street mural. The options included monochromatic colors, bright color patterns and design, whimsical approach, elegant design patterns and interactive pavement art.

In addition, the City asked for ideas about naming the G Street area. At the inperson meeting and survey staff proposed an open-ended question for people to submit their suggestions.

### What we Heard

In the citywide survey, we heard that people resoundingly wanted places to sit, musical engagement, a drinking fountain and a stage. In the in-person meeting the stage was the most preferred amenity. We also heard about the importance

of providing spaces for kids to play. Community members also noted that they liked the arches shown on the Design M concept.

The most popular mural style and color option at both the in-person meeting and survey was bright color patterns and design. Staff also heard that the pavement is in poor condition and adding a mural onto the existing pavement may not be prudent.

The open-ended question to name G Street resulted in no consensus. The name with the most votes, with over 20% of survey respondents was "G Street". Other suggestions include G Street Plaza and "G". At the in-person meeting, there was interest in naming this area, G Street pedestrian gateway and G Street Plaza.

# 5. Parking Preferences, 3<sup>rd</sup> Street to 5<sup>th</sup> Street and 2<sup>nd</sup> Street to the H Street parking lot

In addition to the asking questions about the G Street design, as requested by City Council, staff also engaged community members on parking between 3<sup>rd</sup> and 5<sup>th</sup> Streets and between 2<sup>nd</sup> Street and the H Street parking lot.

Parking between 3<sup>rd</sup> Street and 5<sup>th</sup> Street

Staff presented three parking options to respondents.

Option 1: Existing Conditions with 53 parking spaces.

Option 2: Maximum Parking with 66 parking spaces. 13 more than the existing conditions. Angled parking on both sides of the street.

Option 3: Alternative Option with 59 parking spaces. 6 more spaces than existing conditions. Angled parking only on one side of the street and parallel parking on the other side.

Parking between 2<sup>nd</sup> Street and the H Street Parking Lot

Staff presented two parking options.

Option 1: Parking on both sides of the street to create 2 spaces.

Option 2: No parking on the west side of the street. Instead, there is a protected bikeway for people on bikes headed southbound. This option removes 6 parking spaces.

What we Heard

At both the in-person meeting and survey there was no clear consensus for the parking options between 3<sup>rd</sup> and 5<sup>th</sup> Street. There was a 36-vote difference in favor of maximizing parking with 207 votes and existing conditions with 171 votes.

Similarly, there was little consensus for parking between 2<sup>nd</sup> Street and the H Street parking lot with 58 more people supporting option 2 to create the protected bikeway. At the in-person meeting 60% of respondents preferred Option 2. Staff also spoke with people who work in the building in the northeast corner of 2<sup>nd</sup> and G Street who shared that they observe drivers entering and exiting the H Street parking lot traveling the wrong direction regularly. They recommended that G Street be one-way and exit onto H Street.

### Menu of Options and Costs

After the community meeting Staff worked with PSOMAS to develop a menu of options and costs considering the desires of the community. Below is a table with a menu of options and their costs. With a budget of \$1,057,400 staff is requesting City Council direction on what improvements they would like in the near-term. Staff plans to seek additional grant funding and partnerships with local organizations in the future to make additional improvements that the City Council may wish to see achieved outside of current budget allocations.

This menu includes items that we heard from the community and City of Davis staff. We received comments from community members to include waterlines and hoses for businesses to clean their platforms, the gateway arches, and electrical outlets for events. In addition, there have been several requests for bicycle parking. Bicycle parking is not on this list, because we consider Bicycle parking to be a given and there will be ample bicycling parking throughout this project area.

Table 1: List of Menu Items for G Street Project

### Concept C

One request that has been expressed outside the survey process is to allow the dining space to be adjacent to the businesses and move the sidewalk to the outside of the fenced eating areas. Staff has concerns about this due to the following reasons.

- If the sidewalk is moved to the outside of the platform near the fire access lane, then window shopping will be greatly impacted. Customers may not be visually drawn to a store in this scenario and in some places would have limited access unless significant ADA improvements were made to allow direct access to the platform for each business.
- 2. Due to the grades on the street, the platform will not be flush with the existing sidewalk in all locations as can be seen by the cross section in attachment 2, especially on the east side of the street and there will be up to a 7-inch difference in elevation. If the sidewalk remains where it is this elevation difference would become part of the fencing system, eliminating the potential tripping hazard. If the sidewalk is relocated closer to the middle of the street then, restaurants would have to add ramps or barriers inside their leasable space to allow ADA access.
- Additionally, along the west side of the street, many of the buildings that house
  multiple businesses would need to have reduced or eliminated dining space in
  order to allow a path of travel to the front doors of the businesses, reducing the
  leasable area that would be available.

### **Design Guidelines**

The final step of this process will be to develop design guidelines that allow for businesses that want outdoor dining, or to use space for another use, to know what the program costs would be for renting the space and what the City's expectations are in

terms of materials and maintenance of the outdoor spaces. Design guidelines will provide parameters for aesthetics and safety.

If the design and construction project is approved to move forward, the parallel process will be to create the mechanisms to facilitate business owners in creation of a higher standard of outdoor spaces using the new design guidelines. This will include a licensing agreement to codify: the length of time committed to the use, the requirements for businesses using outdoor space on G Street for commercial benefit, and the licensing fees which will cover the rent. Staff will work on an application process that will ultimately result in a license agreement.

Prior to bringing the guidelines back to the City Council for consideration, staff will be reviewing them with business along G Street and the DDBA to solicit their thoughts and feedback.

### **Recommendations**

Staff is recommending the City install the platform, fencing and planter barriers, and decorative lighting. This option does not include any additional amenities or improvements to the roadway but, is achievable with the available funding.

### Benefits

- City provides features for public spaces and creates fencing for business spaces.
- Can be constructed for use in 2024.
- Limited construction and impacts to businesses.
- Allows businesses to populate the rentable platform spaces with their furnishings consistent with design guidelines to be adopted.

### Considerations

- Adding a platform would prevent for this space to be flexible for other events and uses. For example, the fire lane would have to be kept clear of any permanent objects such as furniture. However, there would still be an opportunity for special events such as food trucks. Larger elements, such as the City's mobile stage, would have to be deployed just outside of the closed area, like what was done at the October concert when the intersection of 3<sup>rd</sup> and G was closed for a pop-up concert.
- If the City is awarded a grant or receives funding to fix the existing asphalt and sidewalks or there is a need to access the existing utilities, then there is

a possibility that the platform or a portion of it might be temporarily removed during construction. However, this is also an advantage to the platforms in that they can be removed temporarily if the area underneath needs to be accessed.

### Parking

While the survey did not come to a conclusive preference from the community on the proposed parking changes there was slightly more desire to remove parking south of the project limits (2<sup>nd</sup> to the H Street parking lot) to add a bike lane and maximize parking north of the project limits (3<sup>rd</sup> to 5<sup>th</sup> Streets).

Staff is recommending keeping the existing conditions for the parking spaces between 3<sup>rd</sup> Street and 5<sup>th</sup> Street for the time being, since the existing travel lanes are wider than what was proposed in any alternative this will allow for easier use of the parking spaces, and provide additional room for cyclists and improved visibility for entering and exiting a parking space. This recommendation does differ from the BTSSC's recommendation to modify parallel parking on one side of the street only and would create 6 additional spaces compared to the existing layout.

For the section of parking between 2<sup>nd</sup> Street and the H Street parking lot, staff is recommending restriping the parking on the westside of the street from angled to perpendicular to make accessing the parking spaces easier for drivers. In discussions with the businesses adjacent to these parking spaces the majority of them feel that any loss of parking would be detrimental to the operation of their business. This does differ from the BTSSC's recommendation to remove the parking an add a cycle track.

Since these proposed changes would not be permanent staff can be revisited them at any time if the need for parking in the downtown area is no longer needed or there are other more pressing uses of this area that need to be considered.

### **Next Steps**

Based on the direction from City Council, staff will begin to move forward with designing the recommended alternative and preparing bid documents. The Council would need to approve the construction contract after bids are received for the project.

The City shared two concepts at the community meeting and Survey. Concept A and B. Respondents were asked to select the concept they liked best.




- Existing sidewalks will remain the same on both sides of the street.
- The platform widths vary in Concept A and B. New platforms will be constructed on both sides of the street at equal widths. The platforms will extend from the sidewalk into the street. Platforms are needed because in some sections of the roadway the sidewalk height is lower than the middle of the street. In addition, the platforms are needed to maintain drainage pathways and connect to existing stormwater infrastructure. Platforms will make the space flat and accessible to all.
- There is a minimum fire access lane requirement of 20 feet wide. The fire lane must be clear of obstructions.

















# 3RD TO 5TH PARKING LAYOUT | MAXIMIZED











### Q6 How often do you use or visit G Street?












## CONCEPT A | Maximizes Retail/Dining (21' Shared Use Space)








## CONCEPT B | Maximizes Shared Use Space (~29')
