

City of Davis Police Accountability Commission Meeting Minute Monday, May 1, 2023

1. Call to Order & Roll Call

Canning called the meeting to order at 6:32pm.

2. Approval of Agenda

Escamilla-Greenwald moved, with a second by Sherman, approval of the agenda. Motion passed by the following vote:

3. Brief Announcements from Staff, Commissioners, and Council Liaisons

- Canning hard week in Davis with two murders.
- Horton community looking to the Davis Police Department to make people feel safer. Stepping up patrols around parks and schools. Caution dragnet style law enforcement. Be careful of indiscriminate stepped-up policing. Today is International Workers Day – pay tribute. Received outreach from member of the public about police interaction related to unhoused individuals. Will share more at next meeting.

Independent Police Auditor representative Stephen Connolly provided an update on Auditor activities to the PAC. Noted that he met with new Deputy Chief Todd Henry and that OIR Group was working to complete the outstanding case logs.

Reviewed 5150 Handling Complaint: no specific recommendations in this report, but touches on mental health issues. Provided recap of investigation, which involved an adult son and a father. Concern from a neighbor was that police should have taken one or both of the individuals on 5150 holds. Department did not feel 5150 criteria had been met. OIR Group concurred. No co-responders were present. At the time of the 911 call, it wasn't clear that it was a mental health issue.
