# 6. Police Auditor Update

Independent Police Auditor Michael Gennaco plans to sit down with Chief Henry soon. There are no new complaints. The NACOLE conference will take place next week and Gennaco will be running panel on prosecutors. Noted there has been a shift in support levels for oversight at state level in other states and provided examples from Tennessee, Arizona, Florida. Concerned that this trend will spread. Will be challenging to figure out what this means for country and oversight.

#### Comments:

- Canning: Are there any movements in CA to increase oversight of sheriffs' departments? (Some counties have oversight - Orange, Santa Clara, Santa Cruz, etc.- but many others don't have.)
- Bliss: What was rationale in states that outlawed oversight? (Rationale was that police don't need oversight.)

## 7. Regular Items

a. Informational Overview on City's Homelessness Response System (Social Services and Housing Director Dana Bailey)

Dana Bailey: provided background information on the Social Services and Housing Department – looking to collect and analyze data, form partnerships, strengthen service delivery. Need to identify the social determinants of health, with focus on affordable housing and social support for vulnerable populations. Point in Time (PIT) count found 162 unsheltered people in the community in January 2024, although actual number is believed to be higher.

Shared the housing continuum and blockages along the continuum: homelessness, emergency shelter, transitional housing, supportive housing, community/social housing, subsidized housing.

Shared environmental scan of challenges and opportunities to getting people into housing and keeping them there. Restrictions on funding and provider capacity are some of the challenges; new initiatives and wide recognition of the problems are opportunities.

Outreach to community organizations to ask what they can and are willing to do to assist with homelessness and related services. Also asked for organizations to listen to voices of people with lived experience.

Grants Pass Supreme Court decision allows local jurisdictions to remove homeless encampments. Davis hasn't necessarily seen people coming to Davis to stay but we are seeing movement through Davis and some clashes between people. Communication with other jurisdictions has been critical. Encouraging people to go to one of the service centers in Davis (Paul's Place or respite) to get connections to services.

Street outreach team: two staff in SSH work with Downtown Streets Team. Partner with County's mobile medicine team and go out to encampments.

Concern about safety and concerns from the community. But also hear the same thing from people living unsheltered. Trying to strike balance for everyone. SSH role is engagement; police role is enforcement/compliance. Trying to form a network of support in Davis for everyone.

#### Commissioner Questions:

- Interest in public-private partnerships? (CalAIM is State's mandate to provide medicare, including having services to assist the homeless. Partnership Health is primary recipient in Yolo County but will require partnerships. City working to help facilitate that.
- Where do people with pets go? (City has partnership with Mercer Clinic and DPAW (Davis Pet Advocacy and Wellness)
- What about unhoused or foster care youth? (District has a McKinney-Vento officer to help unhoused families/children and DJUSD has the access to services for the student. What about unhoused UC Davis students? (UC Davis has Aggie Basic Needs Office. HUD funding doesn't extend to university students.)
- How many people live at Paul's Place? (First floor shelter, second floor transitional housing, 3<sup>rd</sup> and 4<sup>th</sup> floor permanent supportive housing)
- Where do we send people who need housing? (Try to find local locations, but not enough housing to suit all.)
- What about people who are not ever going to be self-sufficient? (City
  practices a Housing First philosophy, trying to get people stabilized in housing
  then work to address their other needs.)

- Concern that Respite Center hours are not long enough.
- Whom do people contact when there is homeless individual? (First should be homeless outreach specialists and then Downtown Streets Team, but if crisis or danger, should be 9-1-1.) There is confusion about who to call and people don't want to call the police for homeless. Need to advertise where people should call, whether that is 9-1-1 or some other number.
- Are boarding houses an option?(There are some regional examples, such as Bay Area Community Services, which uses a shared housing model).
- Do programs involved people in the justice system? (Yes, have taken several from probation Prop 47.)

Interest in having Dana come to February event to explain process (so that people don't have to call police).
