Herdt to extend the License Agreement with Davis Aquadarts through October 2022, while the City concurrently begins the development and solicitation of a formal Request for Proposal process for use of the Community Pool Complex. The motion was seconded by R. Ono, and passed with a 4-2-0-0 vote.
