3. Brief Announcements from Staff, Commissioners, and Council Liaisons.

City Traffic Engineer and Assistant Director, PWET Ryan Chapman: Linda Deos is the new City Council liaison. Fei Ma and Trisha Ramadoss are no longer on the commission. The City has a new street sweeper that attaches to bicycles. UC Davis and the City are collaborating on a traffic detection project. The City submitted a grant for an Active Transportation Plan to Caltrans. The City Council approved an all-way stop and C St and 6th St and updates to the street standards.

City of Davis Safe Routes to School Coordinator, Lindsay Terry: Overview of program, history, goals and upcoming activities.

Public comment:

Trish Price: Wants more motorist enforcement near schools.

Earl Bossard: Agrees with Trish. Wants kids to be dropped off on cargo bikes. Wants safer conditions around schools.

Commission discussion included getting the school board and school district involved in safety and infrastructure connections to the schools. Overall commissioners believe the biggest barrier to riding a bike to school is safety. They want to see more enforcement around schools. They also want to create encouragement to get students to ride bikes.
