# 6. Regular Items

A. Update on Climate Action and Adaption Plan (CAAP) Focused on Transportation.

City of Davis Sustainability Program Manager Kerry Loux: Provided an overview of the CAAP including actions and goals to reduce greenhouse gas emissions. Transportation contributes 75% of total greenhouse gas emissions and the City plans to become carbon neutral by 2040 by implementing aggressive actions.

### Public comment:

Gary Sandler: Wants improved safety by keeping drivers out of the bike lanes.

Commission discussion included investing in better bicycle infrastructure to encourage people to bicycle. Commissioners want better maintenance of roadways and bikeways and improved lighting. Overall commissioners did not prioritize fare free transit, instead they want a more robust transit system.
