A. Street Tree Removal Requests (Charlie Murphy, Urban Forestry Program Manager)

<u>Recommendation:</u> Action Item. Receive presentation from the Urban Forestry Program Manager on the street tree removal requests submitted for this meeting, and consider motions to approve or deny the removal requests. Each request will be accompanied by a public comment period.

B. Draft Peripheral Growth Rubric Feedback (Charlie Murphy, Urban Forestry Program Manager)

Recommendation: Action Item. Review feedback to City Council on the Peripheral Growth Rubric as prepared by the Tree Commission's Draft Peripheral Growth Rubric Subcommittee. The Commission is asked to provide input on the perimeters identified and the grading system used for City Council to consider. Feedback is requested by September 15, 2023. The Commission formed the subcommittee to review the rubric and create recommended feedback at the August Commission meeting.

C. Discussion on Downtown Decorative Lighting Short-term and Long-term Planning (Stan Gryczko, Director of Public Works Utilities and Operations)

Recommendation: Informational/Action Item. Receive information from City staff on work in the downtown to remove existing decorative lighting in trees

and place temporary lighting while long-term planning for decorative lighting in the downtown gets underway with key collaborators, including the Tree Commission. The Commission may choose to provide recommendations to City Council on the efforts to remove lighting, the temporary placement lighting, and/or the process for the long-term plan for downtown decorative lighting in relation to City trees.

D. Consideration of Prioritization of Year One Urban Forest Management Plan (UFMP) Next Steps (Charlie Murphy, Urban Forestry Program Manager)

Recommendation: Informational/Action Item. Begin discussion of possible recommendations to City Council on the prioritization of steps to be undertaken over the next year by City staff with regards to the implementation of the UFMP. Staff recommendations for priorities include: a) the updating and creation of policies, procedures, specifications and standards related to tree care, maintenance, management and planting; and b) continuing the previous efforts undertaken to update the City's ordinance related to Trees (Chapter 37 of the Municipal Code); and (c) conducting an updated comprehensive City tree inventory. The Commission may consider reviewing this item again at their next meeting.
